1. Detail Te Whakamahuki

Purpose and Origin	• This workshop is proposed to provide an overview of the Greater Christchurch Partnership including its purpose, functions and strategic priorities; the governance and structure; the current work programme; and future priorities and opportunities.			
Timing	This workshop is expected to last for 30 minutes.			
Outcome Sought	Council has an understanding / refresh on the Greater Christchurch Partnership and Council's role in the partnership.			
ELT Consideration	ELT is represented in discussions of the partnership through the Chief Executives Advisory Group (Mary Richardson) and Senior Officials Group (John Higgins).			
Next Steps	The Greater Christchurch Partnership Committee will meet on the 5 December 2025. Council will continue to be kept informed of activities of the Greater Christchurch Partnership and will receive further information on the implementation of the Partnership's Independent Review.			
	The Greater Christchurch Partnership Committee (Committee) emerged from the Greater Christchurch Urban Development Strategy Implementation Committee (UDSIC) which was formally established in 2007 to oversee the implementation of the Greater Christchurch Urban Development Strategy (UDS).			
Key points /	 The Greater Christchurch Partnership (Partnership) and Urban Growth Partnership are joint committees established by Memorandum of Agreements under the Local Government Act 2002, to govern and lead the Partnership with the support of their Chief Executives, who sit on a Chief Executives Advisory Group. 			
Background	 The members of the Committee are comprised of: Environment Canterbury (3 voting members); Mana whenua (3 voting members); Christchurch City Council (3 voting members); Selwyn District Council (3 voting members); Waimakariri District Council (3 voting members); Te Whatu Ora – Health New Zealand (1 voting member); Waka Kotahi NZ Transport Agency (1 non-voting member). 			
	 Partnership activity is coordinated at governance, executive and managerial levels [PDF, 615 KB], supported by a secretariat which includes programme management and strategic advisory functions and an Independent Chair role to facilitate Committee and Chief Executive Advisory Group meetings and maintain progress outside of these meetings.

	 Staff from partner organisations deliver the Partnership's work programme through cross-agency project teams which report to a steering group of senior managers from the partner organisations. 			
	The GCP enters the new triennium with a clear work programme focused on:			
	o Addressing the key urban challenges and opportunities facing our sub- region.			
	o Providing the platform for multi-year investment into key infrastructure and initiatives which will future proof our urban area and support our communities to adapt successfully in the context of change.			
	o Ensuring the sub-region is prepared and able to respond successfully to the government's reform agenda.			
	 Council's involvement in the Greater Christchurch Partnership (GCP) delivers clear strategic and operational value through Collaboration and Leadership; Shared Investment; Joint Outcomes; and Influence and Advocacy. 			
	 The Greater Christchurch Spatial Plan (GCSP) and wider GCP objectives align well with Council's planning and delivery activities including implementation of the Ōtautahi Christchurch Planning Programme through local area planning (e.g. Hornby); Plan Change 14 to the Christchurch District Plan; and implementation of the Joint Housing Action Plan.
