2. Submission opportunity - Future of Lichfield Carpark

1. Detail Te Whakamahuki

Timing	This information session is expected to last for 45 minutes.
Purpose / Origin of the Information Session	The purpose of this session is for the Board to consider the consultation currently underway on the Future of Lichfield Carpark and any potential Board feedback.
	The original Lichfield Street parking building sustained significant damage during the 2011 Canterbury earthquake and was demolished and rebuilt on the same site. It reopened to the public in November 2017. The new building is eight-storeys high with 805 parking spaces and retail spaces on the ground floor.
Background	The Lichfield Street Carpark currently generates an operating surplus of approximately \$1.5 million per year (a 3% return on investment). This return is considered low, from a commercial perspective and falls short of the commercial return expected in the Council's Investment Policy of 2024.
Background	Given the underperformance of the asset from a commercial standpoint, and the fact that its original objectives are now also being met by private sector carpark providers, the Council believes there is a strong case for exploring options for the future of the facility.
	As part of the 2024/25 Annual Plan process, the Mayor and Councillors asked for a review of Lichfield Carpark. They raised important questions about the building's performance, the effective use of public funds, and whether continuing to own the carpark aligns with the Council's long-term strategies. On 4 June 2025, the Council decided to seek public feedback before making any decisions on the future of the carpark.
	Consultation on the Future of Lichfield Carpark opened on 10 November and closes on 7 December 2025. Feedback is being sought on two options:
	Option 1: Retain and change
Key Issues	Council would retain ownership of the carpark but change the operating model to improve financial performance.
	Option 2: Sell
	Council would sell the asset and reallocate the funds to invest in other infrastructure or community assets or pay down debt.
Next Steps	Board members should consider whether a Board submission should be made on the Future of Lichfield Carpark consultation and the contents of any submission.
