7. Simplifying Local Government reform: Council Submission

Committee Comment

1. Council Officer Luke Adams joined the table to present Item 7 and answer questions from elected members (refer attached presentation).
2. During questions, Councillor Coker proposed the inclusion of an additional submission point to the Council's draft submission regarding regional councils remaining in place while the reorganisation plan progresses. After further discussion, the proposed submission point was updated to indicate when the new model should be in place (refer Resolution 3(a)).
3. The motion, including the proposed submission point, was then Moved by Deputy Mayor Henstock and Seconded by Councillor Coker.
4. The meeting also agreed to include a further recommendation delegating authority to a subset of elected members to approve any further minor changes to the draft submission before being lodged (refer Resolution 4).
5. At the conclusion of debate, the motion was voted on and declared carried.
