SUMMIT ROAD PROTECTION AUTHORITY SUBMISSION TO THE CHIRSTCHURCH CITY COUNCIL ON THE SUMMIT ROAD SPEED LIMIT REVIEW

The Summit Road Protection Authority is constituted under the Summit Road (Canterbury) Protection Act 2001. The purposes of this Act are:

- (a) to provide for the preservation and protection of the scenic amenity associated with the Summit Road and other roads, walkways, paths, and public open spaces within the protected land:
- (b) to provide for the preservation and protection of natural amenities associated with land within the protected area:
- (c) to provide for the improvement of facilities for the public enjoyment of the scenic amenity and the natural amenities.

For a number of years the Authority has been extremely concerned about antisocial behaviours on the Summit Road and resulting damage to the amenities and facilities of the Summit Road corridor. The Authority welcomes the Summit Road Speed Limit Review as potentially addressing at least one form of antisocial behaviour relating to speeding and the risk of unsafe driving speeds resulting in damage to the amenities and facilities of the Summit Road or attracting antisocial behaviour to the area.

The Authority's concern for the public enjoyment of the scenic amenity and natural amenities of the Summit Road and other roads, walkways, paths, and public open spaces within the protected land surrounding the Summit Road motivate it to endorse initiatives improving the safety of users of the Summit Road.

The Authority and its Advisory Committee have considered the Summit Road Speed Limit Review and resolved to:

Support the proposed reduction of the speed limit to 60 km/h on Summit Road (Godley Head – Gebbies Pass Road) and sections of adjoining side roads as proposed.

The Authority and its Advisory Committee also:

Requests that City Council staff investigate the intersection of Summit Road and Dyers Pass Road with a view to improving the safety of the intersection.

The Summit Road is an immensely valuable asset to motorists, cyclists and walkers in terms of its scenic and natural amenities; these users should all be able to take in the views and scenery safely, and key to this is moderating the speed of motorists without imposing unreasonable restrictions. The Authority supports the balance struck through a 60 km/h speed limit, and requests ongoing safety improvements, noting their concern for the safety of the intersection of Summit Road and Dyers Pass Road, and interest in ensuring the safety of cyclists and walkers is also considered.

SUMMIT ROAD SPEED LIMIT REVIEW

We're reviewing speed limits across our roading network to make Christchurch roads safer.

Project status: Open for feedback Open for feedback: 11th March 2019 - 8th April 2019

To improve safety for everyone we're proposing to change the speed limit from 100km/h (and 70km/h) to 60km/h on Summit Road. Adjoining side roads, Broadleaf Lane, Worsleys Road, Mount Pleasant Road, Evans Pass Road and Sumner Road are also included in the proposal.

Why review the speed limit?



Slowing down saves lives, with a strong link between speed and safety on our roads .

We want to make Christchurch roads as safe as possible so we are reviewing speed limits across the city's roading network where there are concerns they are not safe or appropriate.


Having speed limits set at the correct level for the conditions on specific roads is one of the most important ways we can help people get to where they need to go safely.

A drop in speed on Summit Road and the five adjoining side roads may also help address some of the antisocial road user behaviour happening in the area and make it a more enjoyable space for recreational users.

Setting speed limits

The Christchurch City Council's Traffic and Parking Bylaw 2017 allows Council to set and change speed limits on roads within Christchurch in accordance with the **Speed Management guide(external link)** and the Land Transport Rule: **Setting of Speed Limits 2017(external link)**. Consultation is required as part of this process.

The decision-making process

Sumner Road reopening



Sumner Road will reopen from 6pm on 29 March 2019.

Christchurch City Council and NZ Transport Agency are working to reopen Sumner Road, from Evans Pass to Lyttelton. Contractors have spent the past two-and-a-half years working to reinstate Sumner Road, which has been closed to traffic since tonnes of rocks came tumbling down onto it from the surrounding cliffs during the 22 February 2011 earthquake.

The Advisory Committee noted the Applicant's representation in their presentation that they would be willing to accommodate other operators within their facility where reasonably possible to assist with minimising such facilities, recognising that the Applicant may be restrained in this by the terms of the licence with the Christchurch City Council.

 - o maintains the facility to its current discrete and tidy non-reflecting painted finish,

 - the Applicant promptly agrees to a licence offered by the Christchurch City Council to occupy the unformed legal road;
 - the term of the license agreed with the Christchurch City Council (including the term of rights of renewal) has not expired;
 - the Applicant (or any assignee of the licence permitted under its terms):
 - o complies with the terms of licence with Christchurch City Council,
 - \circ maintains the facility to its current discrete and tidy non-reflecting painted finish,
 - refrains from expanding the facility in its external dimensions and elements, and
 - \circ $\;$ maintains current levels of public access around the facility.
