3. Proposed Road Closures for Mitre 10 Cup Rugby Matches 2019

1. Purpose of Report

1.1 The purpose of this report is to provide information and seek approval from the Road Closure Subcommittee on the proposed road closures associated with the Mitre 10 Cup Rugby Matches 2019 at Orangetheory Stadium.

2. Staff Recommendations

That the Road Closure Subcommittee:

- 2. Authorise the approval of the road closure of Jack Hinton Drive, From Whiteleigh Avenue to Twigger Street:
 - a. From 12 noon to 5.30pm Sunday 18 August 2019

 - c. From 5.30pm to 11pm Thursday 19 September 2019
 - d. From 5.30pm to 11pm Saturday 28 September 2019
 - e. From 2.30pm to 8pm Sunday 13 October 2019
 - f. From 5.30pm to 11pm Friday 18 October 2019
 - g. From 12.30pm to 6pm Saturday 19 October 2019

3. Key Points

- 3.1 Public consultation was carried out through standard channels with the period of time allowing for objections to be received meeting the minimum time period of one week. The application was publicly notified on 17 June 2019 with objections closing on 25 June 2019. There were no objections received.
- 3.2 The purpose of the proposed closures is to facilitate public access and egress to Rugby Matches, held at Orangetheory Stadium, for the Mitre 10 Cup rugby matches 2019.
- 3.3 Road closures for Rugby Matches have previously been approved by the Road Closure Subcommittee at this location in the proposed format.
- 3.4 There is only one direct vehicle access way onto the section of Jack Hinton Drive proposed to be closed, Park Lane Retirement Village. This property has alternative access from Whiteleigh Avenue that will be unimpeded by the proposed closure.
- 3.5 The proposed closures include the closure of Twigger Street which has residential properties on it. Resident access is proposed to be maintained by way of a pass system where vehicle access will be maintained via the Wrights Road entry to the Stadium and Raceway complex when Twigger Street is closed. The proposed closures include a scheduled reopening of Twigger Street that facilitates resident access during matches, after kick off until part way through the second half of matches, to reduce the restriction on access to Lincoln Road from Twigger Street. The reopening of Twigger Street was developed as a way to facilitate access for residents who were concerned with regards to restrictions imposed during the closure of Twigger Street. The deployment of staged closures and reopening has received favourable feedback from the residents of Twigger Street when deployed for other events already undertaken.
- 3.6 To mitigate the impact of the proposed closure of Twigger Street, a drop off zone will be established on Lincoln Road between Lindores Street and Twigger Street, when Twigger Street is closed.
- 3.7 The event organisers have contacted the local residents, via letter drop, to provide details of the proposed closures and to provide an opportunity to engage with them should residents have any issues. The event organisers will supply information to the Subcommittee regarding the feedback they have received.
- 3.8 The Christchurch Transport Operations Centre supports the proposed closures and believes the proposed closures will not unreasonably impact traffic.
