1. Brief Summary

- 1.1 The purpose of this report is to provide the Multicultural Committee with the notes from the 16 July 2020 Multicultural Advisory Group (MAG) meeting, and to welcome the new Chair of the MAG, Katrina Azer who will give a verbal briefing to the Multicultural Committee. <u>Lisa Gregory- Culture Galore</u>, Ray Blank Park. Culture Galore is a multicultural festival that celebrates our city's diversity with food, arts and crafts, music and dance performances from more than 30 cultures who call Christchurch home. The festival creates an opportunity for different ethnic groups in our community to showcase their culture. The first event took place in 2001. Lisa advised that the event was independently reviewed recently. Feedback supported keeping this event local but also that the event had reached a stage where is could be delivered for the whole city at a more central venue. Lisa advised that the funding for this event is provided through Fendalton Waimairi Harewood and Hornby Halswell Riccarton Community boards. It is anticipated that future planning for the event will be in partnership with ethnic communities via a working group. Lisa is currently working on a nomination process.

Feedback from group:

Members who have attended the Culture Galore event in the past commented on how safe the event is, a place where kids can run around freely, members observed a good level of cooperation between the different stalls owners. Suggestions to have more multicultural information stalls at the event and to include a health information stall. Some members expressed the idea of having a larger venue in a more central part of town where there would be more parking available. Members and Councillors both agreed that the parking was an issue. A member suggested to Lisa to use the MAG for advice to feed into the working group

A councillor commented that if this event did explore the option of having it in a more central location that they could potentially apply for metro funding.

Members concluded with advice to Lisa to think big when planning for the next Culture Galore event.

<u>Overview of Ngai Tahu</u> and our partnership with Mana whenua. Carried forward.

Actions from previous minutes N/A

Introduction from Paul Reaves, Area Prevention Manager NZ Police

Paul spoke about the range of objectives his team are involved with which include education around driver's licenses and educating multicultural families how to report crime. Since his team began working with families, they have seen 60% reduction in offences. Multicultural family issues are directed to his team. Paul's team have had recent training in unconscious bias. Paul's team have a focus on building a sense of security and reassurance with the Muslim community. Paul will aim to invite the District Commander to talk with the MAG.



Paul is happy to address the community explaining what is classed as crime here in NZ in comparison to other countries. If Paul could get a referral he is happy to inform the community.

There is now a front line officer's training package for new staff with an emphasis around cultural awareness. Paul also emphasised the internal support for ethnic policing staff. Paul's team provide a wraparound service one at a time to keep people out of the judicial system.

Pauls team also work with ethnic small business owners on crime prevention through environmental design and an alert system that his team have recently adopted.

One member acknowledged the efforts of some of Paul's team (Murray) who were in attendance at the kids holiday programme in the mosque recently.

Another Member enquired if the police could work alongside immigration, this member has noticed a gap in highlighting a cultural difference around crime offences here in New Zealand in comparison to some countries. Councillor Anne Galloway queried if there would be another chance for the MAG to talk to Paul in the future. Claire invited the Police to have a regular presence at the MAG meetings and to work in partnership with Council.

An independent Trust and multicultural governance Board of Trustees will be established to manage the facility with a broader Multicultural advisory team to guide the Centre development. . where it is comfortable and accessible for everyone. Gary mentioned that the MAG would have an opportunity to have some input on internal cosmetic design, the official naming and the art work.

1. Brief Summary

- 1.1 The purpose of this report is to provide a progress update on the implementation of the Multicultural Strategy.
- 1.2 Update the Committee on the Community Multicultural, Sports and Recreation Centre.

2. Officer Recommendations

1. Receives the report on the Multicultural Strategy Implementation Plan update.

3. Multicultural Strategy Implementation Plan – Progress update

Goal 1: Christchurch City Council is an inclusive and diverse organisation

Priority Action 1: Highlight, promote and grow diversity and inclusion in Council

Welcome Signage - Multilingual welcome signage has been completed and signed off by the Department of Internal Affairs Translation Services. This signage will be rolled out across Council facilities in line with the Communications and Engagement Strategy.

Inclusion and diversity programme - The Chief Executive launched a work programme at the Annual Leader Workshop on 5 November 2019 (all leaders) - One Team/Kotahi te kappa. This programme aims to increase awareness and understanding of inclusion and diversity and embracing this to become a more inclusive Council.

Activity so far has included:

- The creation of an intranet page where staff can access resources to assist them in understanding diversity and inclusion http://intranet.ccc.govt.nz/training/one-team
 This includes recordings, readings and cultural awareness e-learning modules.
- All leaders participated in a 3-hour interactive discussion session on inclusion at the Annual Leaders Workshop. This was led by the Executive Leadership Team.
- Leaders are currently in the process of running a 45 minute inclusion discussion with their teams. This utilises video content from the leaders' workshop.
- All staff have been asked to complete 3 x 20 minute e-learning modules on unconscious bias. 67% of employees have now completed all three Unconscious Bias modules. This work is ongoing.
- The e-learning modules on unconscious bias will become part of our standard induction for new employees.



<u>Priority Action 2: The Council builds and maintains relationships with all communities and their organisations</u>

INFORM- Interagency Network for Refugee and Migrants - Council continues to facilitate the INFORM network on behalf of the sector. During the Covid19 level 4 lockdown, meetings were still held via zoom. The first face to face meeting since the lockdown will be held at the Oxford Terrace Baptist Church on 7 August 2020. This meeting will be an opportunity to understand better the issues multicultural communities faced during lock down, how agencies responded and to plan collectively for the anticipated challenges ahead.

Goal 2: All communities have equitable access to Council services and resources

Priority Action 1: Identify and remove barriers to accessing Council facilities, events, services and processes experienced by people because of their identity, cultural or linguistic backgrounds

Multicultural Advisory Group (MAG) - The MAG met on 16 July 2020, the second official meeting since the MAG's inception. The group have been unable to meet until now due to Covid19 restrictions. The notes from the 16 July meeting have been included in an earlier report to the Multicultural Committee.

NZ Police will be attending meetings in the future as we partner with the MAG for broader outcomes. A verbal briefing from the newly elected MAG Chair will be made at today's meeting.

Goal 3: All residents are able to participate in Council decision-making

<u>Priority Action 1: Enable and promote participation in civic life and public decision-making by people from all communities</u>

Translated information - To help promote Council's re-consultation on the updated Draft Annual Plan, Council translated posters into Te Reo, Arabic, Farsi, French, Korean, Samoan, Simplified and Traditional Chinese, Spanish, Russian, and Tagalog. The posters, distributed via stakeholder networks, let people know about the re-consultation post Covid19, and how people could have their say.

Goal 4: Ōtautahi/Christchurch is a city of cultural vibrancy, diversity, inclusion and connection

Priority Action 1: Celebrate and foster linguistic diversity of all Christchurch peoples

Annual Strengthening Communities Fund - Staff recommendations, where relevant, for the allocation of 2020/2021 Strengthening Communities funding (SCF) reflect the importance of maintaining language, culture and heritage. The Sustainability and Community Resilience Committee will approve Metropolitan SCF applications in late August. Local funding applications, allocated on a board by board basis, have been assessed the same.

Priority Action 2: Inform the wider community about the value of diversity in Christchurch

Employment and Training Subgroup - This subgroup of the INFORM network has been resurrected in response to existing and anticipated needs of Refugee and Migrant communities (a vulnerable labour force) as a result of Covid19 related unemployment.

This sub group comprises agencies and multicultural community representatives such as the Canterbury Employer's Chamber of Commerce, Christchurch City Council, Ministry of Social Development, Immigration NZ, Red Cross, PEETO/Wilkinsons Language School, Hagley Community College, the Korean community, the Chinese community, Muslim Association of Canterbury, Christchurch Resilience Foundation and the Refugee Resettlement and Resource Centre. Membership is open. The purpose of the subgroup is to:

- Address all matters employment, unemployment and training opportunities for Migrant and Refugee people- specifically focussing on permanent residents/citizens.
- To identify and explore positive options for the target cohort re jobs and training
- To liaise with all appropriate stakeholders in a lobbying and advocacy role
- To consult the Refugee and Migrant communities re solutions and outcomes

Priority Action 3: Strengthen and connect all Christchurch people and communities

The Community Activation Fund (CAF) - The Christchurch Community Activation Fund seeks to provide support for small community initiatives that improve community safety, participation, inclusion, and connection for communities affected in any way by the Christchurch terror attacks. The fund is provided by the Ministry of Social Development and is jointly managed with the Office of Ethnic Communities and Christchurch City Council. Since being established in October 2019, the fund has granted \$167,827 to 105 projects. An estimated 18,000 participations occurred in these events or projects, with a total of over 7,000 volunteer hours going into them. (For total allocations to date see *Attachment A*).

The African Women International Women's Day - The International day was held at Te Hapua/Halswell Centre Friday 7 March 2020, was held, opening it to the public and all local international women in the area. The event was an opportunity to meet other local women and share a meal and here from guest speakers.

This International Women's Day event is always held on the south West side of town, representing the large number of women from different ethnicities in the Halswell, Hornby and Riccarton wards. The venue was originally to be held in a Hornby Church Hall, but has now become too small because of the growing number of attendees. The Halswell, Hornby and Riccarton Community Board has made a contribution towards venue costs.

Dress code swimming for women and children - The Wharenui Pool will run two women's only sessions – Saturday 5.15pm – 6.15pm with a dress code, and Sunday 6.15pm – 9.15pm with a flexible dress code. A 10 week trial was disrupted due the COVID 19 Level 4 Lockdown. The first dress-code session attracted 50 women and children and it is anticipated these numbers will grow.

4. Community Multicultural, Sports and Recreation Centre

On 25 June 2020 Council resolved (CNCL/2020/00080) for staff to begin negotiations for the purchase of the Canterbury Netball Centre in Hagley Park for possible use as a Multicultural, Community and Recreation Centre. Staff had previously completed due diligence on the structure, which was found to be in good condition with all earthquake repairs completed.

Hagley College have been actively involved in the design of this proposal and although unable to make a financial commitment to the purchase, are a committed partner in the development of this project through membership on an independent governance board.

Since the media announcement, Council has received a number of emails reinforcing support for the Centre proposal. Council property staff are now beginning purchase negotiations with Canterbury Netball, which is expected to be completed over the next three months.
