


1. Apologies / Ngā Whakapāha

3. Background

- 3.1 The feedback period denotes the first phase of consultation for revisiting the Council's 2007 Strengthening Communities Strategy. The feedback received on the exiting strategy will be incorporated to form an amended strategy. This will then be released for consultation with the community and the Board having the opportunity to submit on the amended document before it is adopted by the Council.
- 3.2 The Council's strategies are key direction-setting documents. They articulate a vision for the future, describing goals we want to achieve and/or problems we want to solve, and they set out a road-map for how we are going to do this.

4. Feedback questions to consider

4.1 Thinking of people of all ages, abilities, ethnicities, interests and identities, what does a healthy and connected community look like?

4.2 People

- A. What are the best ways we can build a community where people are treated equally, feel included and diversity is welcomed?
- B. What are the main obstacles preventing that happening?

4.3 Places

- A. What would increase our sense of belonging?
- B. What can we do to increase our use of public spaces and places?

4.4 Participation

- A. How do we encourage more residents to become involved in community activities?
- B. Do you feel like you have the opportunity to be involved in decision making?
- C. If not, what are some of the reasons stopping you from taking part?

4.5 **Being prepared**

- A. What can the community do to prepare for disruption and change in our lives?
- B. What do you think the Christchurch City Council's role is in helping to build strong and resilient communities?
- C. Can you identify the top three opportunities that Council should focus on in its Strengthening Communities Strategy?
