Approves that any previously approved resolutions on Ferry Road from its intersection with St Asaph Street to its intersection with Barbadoes Street, pertaining to traffic controls (including the speed limit), parking restrictions, and stopping restrictions made pursuant to any bylaw, to the extent that they are in conflict with the traffic controls, parking and stopping resolutions described in recommendations 2-4 below, are revoked.

Ferry Road, St Asaph Street to Barbadoes Street

- 2. Approves all kerb alignments, road surface treatments, bi-directional cycle path, one way northwest bound and road markings on Ferry Road, commencing at its intersection with St Asaph Street, and extending in a south- easterly direction to its intersection with Barbadoes Street, as detailed on plan TP 357802, issue 1, dated 11 January 2021 and attached to this report as Attachment A.
- 3. Approves that the speed limit on Ferry Road, ccommencing at its intersection with St Asaph Street, and extending in a south- easterly direction to its intersection with Barbadoes Street, be set at 30 km/h, in accordance with Clause 27 of the Christchurch City Council Traffic & Parking Bylaw 2017.
- 4. Approves all stopping and parking restrictions on Ferry Road, commencing at its intersection with St Asaph Street, and extending in a south easterly direction to its intersection with Barbadoes Street, in accordance with Clause 7 of the Christchurch City Council Traffic & Parking Bylaw 2017 and as detailed on plan TP 357802, issue 1, dated 11 January 2021 and attached to this report as Attachment A.

Current Williams Street

5. Approves that any previously approved resolutions on Williams Street from its intersection with Ferry Road for a distance of 20 metres in a southerly direction, pertaining to traffic controls (excluding the speed limit), parking restrictions, and stopping restrictions made pursuant to any bylaw, to the extent that they are in conflict with the traffic controls, parking and stopping resolutions described in recommendations 6 – 9 below, are revoked.

Williams Street

- 6. Approves all kerb alignments, road surface treatments, shared paths, one way north bound, stop control and road markings on Williams Street, commencing at its intersection with Ferry Road, and extending in a southerly direction for a distance of 20 metres, as detailed on plan TP 357802, issue 1, dated 11 January 2021 and attached to this report as Attachment A.
- 7. Approves all stopping and parking restrictions on Williams Street, commencing at its intersection with Ferry Road, and extending in a southerly direction for a distance of 20 metres, in accordance with Clause 7 of the Christchurch City Council Traffic & Parking Bylaw

- 9. Approve that the Left turn movement from Ferry Road into Williams Street be restricted for motor vehicles only, as detailed on the plan TP 357802, issue 1, dated 11 January 2021 and attached to this report as Attachment A.

- 12. 5. Significant Council Projects in the Board Area

5.1 South Express Major Cycle Route Update ("MCR")

MCR South Express Section 3 (Deans Avenue to Craven Street) construction is underway. Suva Street and Ballantynes Avenue sections are currently in construction and due to be completed in March 2021.

The contract for construction of the Deans Avenue to Centennial Avenue section has been awarded. Construction will start before Christmas and is due to be completed mid-2021.

The tender for construction of the Centennial Avenue to Cravern Street section has closed. The contract is be awarded before Christmas, with construction starting in the New Year. Construction of this section will take eight months.

MCR South Express Section 2 (Craven Street to Waterloo Road) section construction will get underway in 2021. Hei Hei Road/Waterloo Road traffic signals have been included in the Centennial Avenue to Cravern Street tender to allow these to be constructed early. Construction is expected to take place in the first half of 2021.

Craven Street to Pararoa Stream Reserve design is complete and will be tendered prior to Christmas with construction starting in early 2021.

The rest of MCR Section 2 is currently in the final stages of design. It will be tendered in the first half of 2021 and is likely to be broken up into two or three packages for construction.

MCR South Express Section 1 (Waterloo Road to Templeton) overall detailed design is fifty percent complete and will be fully completed early in 2021. Detailed design on Gilberthorpes Waterloo has been progressed further to allow for Kiwirail's Level Crossing Safety Impact Assessment (LCSIA) to be carried out and reduce any delays to the project.

Gilberthorpes/Waterloo intersection has been through the Kiwirail's safety audit processes. The biggest impact from these audits is that pedestrian gates are required to be installed at the level crossing. The MCR designers are working on the design of these with Kiwirail. Typically, from design to construction of these gates can take Kiwirail around 18 months, but cost effective interim solutions such as a maze can sometimes be installed.

The Templeton and Waterloo Business Park sections will be ready to be tendered once design is complete. A short section along Waterloo Road around Halswell Junction Road Extension

will be constructed with that project and in conjunction with the road closure, this project is currently in design and construction is expected to start in late 2021.

6.1 Hornby Hoops

Hornby Hoops took place on Friday 11th December at Hornby High School. The annual event brought enthusiastic young people from around Hornby to play a 3v3 basketball competition.

6.2 Celebrate Halswell

Celebrate Halswell community event was held this year for the first time. It look place on Saturday 12th December at Te Hāpua Library. Families from across Halswell came together for a fun day of crafts, games and activities.









6.2 126 on the Corner project

> 126 on the Corner's annual sunflower growing competition has started. Seeds are supplied from 30 November with judging taking place in February 2021. The event is supported by a strengthening communities grant

6.3 Halswell Community Project

> The Christmas Giving Tree project is underway at Halswell Hub. All Donations will go to Odyssey House and Open Home Foundation.

6.4 **Riccarton West Community Garden update**

> The move of the Riccarton West Community garden and pantry onto a smaller site has been completed. The Garden is now supported by the Christchurch South Community Gardens Trust.

- 6.5 Hei Hei Broomfield Community Development Trust art classes
- 6.6 In 2019, the Hei Hei Broomfield Community Development Trust received Off the Ground funding from the Board towards art supplies for art classes held at 126 On The Corner. The Trust reports that classes have been a success, with enthusiastic attendees arriving each week to learn a variety of painting techniques. The classes have had a positive impact on attendees, who are able to connect with others and develop their artistic skills.
- 6.7 Carols in the Park

Wycola Park in Hornby was home to Carols in the Park on Saturday 20th December. A wide variety of local Hornby groups came together to organise a community Christmas Carol event, along with a BBQ, games and activities for the whole family to enjoy.

6.8 **Riccarton Sports Hub Holiday Festival**

5. Significant Council Projects in the Board Area

5.1 St Albans Community Centre Rebuild

The rebuild has suffered from the post-COVID back up of supplies which has affected industries across the country as delivery of goods struggles to meet demand. Some final components for the building have been subjected to these delays and the project completion date has been delayed slightly as a result.

The official opening has had to be rescheduled accordingly.

5.2 Christchurch Northern Corridor – Totara Highway

The official opening was held on Saturday 12 December 2020 with the Highway open to cyclists only who enjoyed the view on a leisurely ride down the roadway uninterrupted by vehicles.



There is still work to do before this project is complete. A final low noise asphalt layer will be applied in late 2021 as the chip seal needs to weather for a time for industry best practice.

Minor work is still underway on the northern motorway and work will also continue at the Grimseys and Hills Road subways, on Winters Road and in the QE11 Drive and Cranford Street areas.

Landscaping work along the shared path and motorway alignment is ongoing including weed control and planting more trees and plants in the upcoming autumn season, April to September 2021.

More is to come in January 2021 with the T2 (travel2gether) lanes which will connect with Park & Ride facilities in both Kaiapoi and Rangiora. These will have direct bus services to and from the Christchurch CBD, so it will be



easier for commuters to carpool or take the bus.

From Monday 11 January 2021, Metro's new, fast and direct bus services to central Christchurch will include four morning trips from both Rangiora and Kaiapoi, and five afternoon trips back to each township. The new 91 Rangiora – City and 92 Kaiapoi – City direct bus services are supported by additional Park & Ride facilities provided by the Waimakariri District Council in Kaiapoi and Rangiora to allow local residents to take advantage of the new T2 lanes.

6. Significant Community Issues, Events and Projects in the Board Area

6.1 Joint Papanui and Shirley Inter-Agency Network Meeting

A joint Christmas meeting of the Papanui and Shirley Inter-Agency Liaison Network Groups was hosted by the Papanui-Innes Community Board on 17 November 2020 at the Chapel Street Centre, Harewood.

Emma Norrish, the Board Chair, opened the meeting and asked the members to reflect on the achievements of the past year. The main theme was learning to cope with the COVID-19 lockdown restrictions but the agencies were proud of their solutions in keeping communications open with their communities and their amazing achievements with the food programmes, support and responses to the needs of individuals and families during this challenging time.



6.2 The Santa Claus Workshop Charitable Trust

Malcolm Westgarth, Workshop Manager and Trust Committee member, delivered a generous number of wooden toys handmade by the members of the Workshop during 2020 for distribution to organisations within the Board's area.

These toys are sturdy, beautifully made, fun and functional and are given to children who may not otherwise receive a Christmas present.







6.5 Opening of the Neighbourhood Trust Whānau Centre

On 2 December 2020 the Neighbourhood Trust celebrated the opening of their Whānau Centre at Nancy Avenue .The facility had previously housed the 'Pay it Forward' Craft Shop and since the craft group has now moved to the city, the space is now being used as a street level entry Whānau Centre in the heart of Mairehau. Local community can access food resilience support, CV development and job seeking support, counselling and life skill support modules, ESOL training, Parent and Caregiver support and a fathers' group, plus a wrap-around of



services to support the wider Whānau. Already the space has encouraged the community to come in, access emergency food support and develop trusting relationships with Dawn, the Community Development Worker, and staff and begin to work on and address issues (at the client's pace) that the Trust can support in a practical way.

At the opening the Mairehau School Principal, John Bangma, spoke of the important and longstanding partnership between Neighbourhood Trust and the school, outlining the commitment the Trust has provided as a partner with the school in servicing and providing support to the community. The Trust continues to provide parent support on Wednesday and Friday to parents and also provides a child counsellor for the school Tamariki.



6.6 Northcote School - Community Breakfast Celebration



Council Staff were among the many volunteers that worked to deliver another great Christmas breakfast for the pupils, staff and whānau of Northcote School on Friday 11 December 2020.

Volunteers from Northgate Trust, Papanui Baptist Freedom Trust, Belfast Salvation Army, Kaianga Ora, Redwood Library, St Silas Church, local community police and the Animators based at the Northcote Links Building, set up before 7am and cooked and served an amazing breakfast of scrambled eggs, sausages, pom-poms, bacon, tomatoes, onions, mushrooms, yoghurt, fruit salad, cereals, toast, juice, garlic and rosemary potatoes, pancakes, jam and whipped cream. A special coffee station was also provided for discerning coffee drinkers.

The breakfast served approximately 140 students plus teachers and an estimated 40 whānau who attended in support.

6.8 10 Shirley Road Community Reserve



At the Board meeting on 18 December 2020 the Board approved the installation of a temporary wayfinding sign at 10 Shirley Road. The Richmond Community Garden have a temporary lease to install a wayfinding trail in the residential red zone, the idea being to connect people with places and projects that are happening in the Richmond suburb including the Otakaro Avon River trail, the Richmond Community Garden, Avebury House and Adventure Avenue. The wayfinding sign on 10 Shirley Road is the beginning of the trail.

The Green Lab (previously Greening the Rubble) has now installed the sign in the reserve on behalf of the community. The wayfinding trail is a community driven project, encouraging residents to connect with their neighbourhood and be physically active.

6.10 Relocation of Environmental Monitoring Station St Albans (Coles Place)



The current station at Coles Place is monitored by Environment Canterbury and is located on an area of public open space at the end of Coles Place which is surrounded by residential properties on four sides. It is representative of emissions arising from domestic properties in the older suburban are of St Albans which lies to the north of the Christchurch City Centre.

This now needs to be moved and Environment Canterbury are investigating suitable sites for its relocation. There are quite specific requirements for a suitable site to ensure accurate measurements are recorded.

7. Progress Report Against the Community Board Plan

Updates against outcomes of the Waipapa/Papanui-Innes Community Board Plan will be presented to the Council in an upcoming meeting.

8. Community Board Matters of Interest

8.1 Request for extension of Papanui alcohol ban area

At its meeting on 4 December 2020 the Board received a request from a resident of Erica Street asking that the current alcohol ban in part of the Papanui area be extended.

The Board requested that staff provide information on the feasibility of the request and a memorandum that listed the processes and requirements under the Local Government Act 2002 was delivered to Board members on 22 December 2020. A staff briefing on this matter will be arranged for early in 2021.

Note: The Community Board has now received advice from Council staff regarding an extension to the current Papanui ban. Their advice is that Section 147A(1) of the Local Government Act 2002 sets out the criteria for making a permanent alcohol ban and that these criteria do not include provision for 'pre-emptive' bans designed purely to address the possibility of future alcohol related problems. Under the legislation, problems have to have already occurred/be ongoing before it would be appropriate for the Council to proceed with an extension to the alcohol ban area.

When making decisions whether to impose an alcohol ban the Community Board needs to receive evidence of an existing problem before deciding to support the residents' proposal for an extension to the current alcohol ban area.

Governance staff advised the resident who raised this matter accordingly and suggested that any concerns around alcohol issues are reported to both the Council and the Police so they can monitor any trends that occur.

8.2 RMA Processes

The Board has recently had several complaints of "creeping" changes to Resource Management consents from local residents where a series of variations following the initial resource consents have resulted in considerable disadvantage to the residents.

Another source of concern for inner city residents is the high density changes to the District Plan where developers are building without consideration of the surrounding residential properties and the ambience of the suburb.

8.3 Safety Audit Langdons Road and surrounding transport network

The Board is concerned at the rapid build-up of traffic on Langdons Road since the new Northlink retail precinct opened. Local residents have approached the Board requesting that some kind of pedestrian access be considered across what is now a very busy road.

The matter of lights at the Langdons/Greers Road intersection has also been raised by residents and Board members as it appears the line of cars waiting to turn on to Greers Road has multiplied to the point where it can take five or more minutes especially during peak traffic times.

The Board have requested that a safety audit be done of the Northlands transport network to gauge the effects of the recent changes.

3. Community Board Decisions Under Delegation

The Waihoro/Spreydon-Cashmere Community Board held meetings on 17 November, 1 December and 15 December 2020. Decisions made under delegation were:

- **Parklands Drive No Stopping Restrictions** Following three deputations from residents, the Board approved extended no stopping restrictions on Parklands Drive. The Board requested that staff monitor the impact of the above safety improvements and report back in 12 months. Item 6.4 of this report refers.
- **Recess Committee** The Board appointed a Recess Committee to be authorised to exercise the delegated powers of the Board following its ordinary meeting on 15 December 2020 up until its next ordinary meeting in 2021.
- **Meeting Schedule** The Board adopted its meeting schedule for February 2021. The Board will consider its schedule for the remainder of the year in February 2021.
- **Discretionary Response Fund** The Board approved \$1,050 from its 2020-21 Discretionary Response Fund to Landsdowne Terrace Playcentre towards the Landsdowne Community Centre Mural.
- Youth Achievement and Development Fund The Board approved the following grants from its 2020-21 Youth Achievement and Development Fund:
 - \$200 each to Maria Laurie, Hamish Sherratt and John Laurie towards participation in the national 2020 Get2Go Final adventure challenge.
 - \$200 to Louis Hamilton towards participation in the trials in Canterbury for the Under 17 2021 Korfball World Cup.

4. Part A Recommendations to Council

There are no reports presenting Part A recommendations from the Board included in this agenda for Council consideration.

5. Significant Council Projects in the Board Area

Dyers Pass Road Safety Improvements

- 5.1 Work started on the Dyers Pass Road Safety Improvements project to widen the road in places and install three kilometres of guardrails.
- 5.2 The safety improvements are budgeted to cost about \$7.2 million. Waka Kotahi NZ Transport Agency is meeting three-quarters of the cost as it has included the project in its Safer Networks Programme.
- 5.3 As part of the project, some healthy trees may need to be removed. The Board sub-delegated these decisions to the Chair and Deputy Chair, who approved the removal of one healthy tree in December 2020 on the condition that it is retained and protected if possible. If removed, two replacement trees will be planted in its place nearby.

Pioneer Recreation and Sports Centre Repairs

- 5.4 Following a successful expression of interest process, the repair and earthquake strengthening work for Pioneer Recreation and Sports Centre started in November 2020. The main pool, wave pool, spa and sauna will be closed for six months so the pool plant, roof and air conditioning system can undergo repairs and earthquake strengthening work can be carried out to the pool hall. This follows work already undertaken earlier in 2020 to repair the centre's roof and air conditioning system above the gym, group fitness area and spin studio.
- 5.5 The majority of Swimsmart classes will not be affected, as the Teach Pool remains open. The fitness centre and group fitness classes also remain open as usual.

6. Significant Community Issues, Events and Projects in the Board Area

Public Forum Presentations and Deputations – The Board received public forum presentations and deputations on the following topics:

- 6.1 **Update on Summit Road Society** The Board heard an update on the organisation's activities.
- 6.2 **Update on Pioneer Basketball Club** The Board heard an update on the Pioneer Basketball Club's activities. The Club is limited by the indoor court space at Pioneer Recreation and Sport Centre. If there were an outdoor half basketball court nearby, the Club could coach more children and facilitate three-on-three basketball competitions, which are increasingly popular.
 - 6.2.1 The Board asked for staff advice on options for an outdoor half basketball court near Pioneer Recreation and Sport Centre.
- 6.3 **Canopy Coverage in the Rowley Area** Kainga Ora spoke about its goal to increase the canopy cover in the Rowley area by planting more trees on its properties. Kainga Ora also requested that the Council plant more trees in berms in the area.
 - 6.3.1 The Board asked for staff advice on increasing canopy cover in berms in the Rowley area, including but not limited to Redgrave, Herdman and O'Leary Streets.
- 6.4 **Parklands Drive Proposed No Stopping Restrictions** The Board heard three deputations from residents asking for the no stopping restrictions recommended by staff to be extended to further improve safety around a sharp bend. Residents also suggested additional signage. Item 3 of this report refers.
- 6.5 **Youth Achievement and Development Grant Recipient** Lewis Chihiro Stewart, who recently received a grant from the Board towards competing at the Rembuden Kendo Taikai, provided an update on the competition.
- 6.6 **Kereru Sport and Cultural Club** The Board heard an update on the organisation's activities.

6.7 **Innovating Streets for People Project – Better Beckenham and Selwyn Street** – The Board heard an update on the Innovating Streets projects.

6.7.1 Staff will bring a report to the Board on the projects in early-2021.

- 6.8 **Update on Canterbury Kids Coach** The Board heard an update the organisation's activities.
- 6.9 **Huntsbury Preschool** Huntsbury Preschool raised concern with an increasing number of preschools in the area.
 - 6.9.1 The Board asked for staff advice on existing resource consent requirements for new preschools and if consent requirements could include a limit on trade competition.
- 6.10 **Project Esther** Project Esther Charitable Trust has been working with women and their families for almost two decades. The Board heard an update on the organisation's activities.
- 6.11 **Begging at Barrington Mall** Barrington Mall spoke about ongoing concerns with begging on Council property near the Mall.
 - 6.11.1The Board asked for staff advice on whether there are any traffic safety or footpath obstruction issues resulting from the proximity of any individuals begging close to the entry/exit to Barrington Mall on Barrington Street.
- 6.12 **Odour Assessment Pilot** Environment Canterbury (ECan) presented findings from a pilot that assessed odours near Bupa Care Services Limited in Cashmere. ECan confirmed that Bupa is not meeting its permitted activity status. Next, it will look at a collaborative approach with Bupa to gain compliance and to balance needs of the community. The Board expressed its appreciation for ECan working innovatively to resolve this longstanding issue.
- 6.13 **Update on Public Transport Project** Dr Angela Curl, Senior Lecturer, Otago University, spoke regarding the Spreydon-Cashmere Age-Friendly Public Transport Project, highlighting the proportion of the population in the area with accessibility to bus stops within 400 metres or 250 metres of their home.

6.13.1 Dr Curl will present additional findings to the Board in early-2021.

6.14 **Parking on Rose Street** – The Board heard from a resident regarding parking issues on Rose Street. Item 6.18 of this report refers.

Correspondence – The Board received the following correspondence:

- 6.15 **Parking on Rose Street** The Board received correspondence from a resident highlighting the limited parking on Rose Street as protected grass verges block cars from parking on the side of the road. The resident also noted that steel waratahs and large rocks that have been placed on the roadside to protect the verges could pose a health and safety risk to passers-by.
 - 6.15.1The Board asked staff to consider addressing these issues as part of the Capital Regeneration Acceleration Fund (CRAF) programme or other budgets.
 - 6.15.2 The Board also asked staff to investigate whether steels waratahs and large rocks on the roadside pose a health and safety risk to passers-by such as cyclists.
- 6.16 **Request for Tree Removal** The Board received correspondence from a resident requesting the removal of a tree on Rossmore Terrace.
 - 6.16.1 The Board asked staff to investigate whether pruning the tree will resolve the issues. If not, the Board asked staff to provide further information at a future meeting.

- 6.23 **Sydenham Cemetery** A Board member noted that some members of the community have ongoing concerns with Sydenham Cemetery, including poor drainage and rubbish.
 - 6.23.1 The Board asked staff to provide an update on work to improve the amenity and safety of Sydenham Cemetery.
- 6.24 **Safety at the Wilsons / Centaurus Roads Roundabout** It was noted that St Martins School raised safety concerns with the Wilsons / Centaurus Roads roundabout and nearby pedestrian crossings.
 - 6.24.1 The Board asked staff to investigate options for improving the safety of the area for pedestrians, cyclists and motorists, including students of St Martins School and a preschool at 3 Wilsons Road.
- 6.25 **Curletts Flood Storage and Stormwater Basin** A Board member noted that vegetation in the Curletts Flood Storage and Stormwater Basin has died.
 - 6.25.1 The Board asked for staff advice on the reason that vegetation has died and what steps will be taken to re-plant the area and ensure that vegetation will survive.
- 6.26 **Cycle Safety** A Board member noted that a resident proposed running a competition for schools to design bumper stickers to improve cycle safety.
 - 6.26.1 The Board asked staff to support the resident to develop a proposal to improve cycle safety in the Spreydon-Cashmere area in more detail.
- 6.27 Community and Youth Service Awards and End of Year Function The Board's Community Service and Youth Service Awards for 2020 were successfully hosted on Thursday 3 December. Board members presented fifteen awards, including two youth and one group awards, as a way of recognising the valued service occurring in the community. The awards presentation was immediately followed by the Board's annual End of Year Function.





- 6.28 **Addington Heritage App** Prototype pamphlet versions of two historic features walks was presented at the annual Addington Heritage Evening to an audience of some 40 people. The Addington Neighbourhood Association plans to provide the electronic copy to local accommodation businesses to complement the online app.
- 6.29 **Hunter Terrace Pump Track** A meeting was held with local residents, Better Beckenham, Gravity Canterbury, 44 Design and Council staff to discuss the new design and upgrade of the pump track on Hunter Terrace. This project is being community-led with support from the Council as required.
- 6.30 **Hoon Hay Community Centre Feasibility Report and Business Case** Following a request by the Hoon Hay Community Association Trust, the Council commissioned a feasibility study for the Hoon Hay Community Centre. The feasibility study recommends that the Trust prepare a Strategic Plan to develop a shared vision, goals, objectives and a work programme towards these, including a marketing plan and facility activation plan. Staff will support the Trust with preparing this.
- 6.31 **Champ Nations Youth Academy** A new youth programme has been initiated in partnership with Spreydon Youth Community Trust, Hillmorton High School, Champ Nations and the Council to help address some ongoing concerns with young people initiating fight clubs. This programme will teach young people values, discipline, fitness and whānau and how to support each other post COVID where anxiety, frustration and stress has been exacerbated in young people. The target age group is Years 8 to 10.



7. Progress Report Against the Community Board Plan

- 7.1 At its 18 August meeting, the Board adopted its Community Board Plan 2020-22. A six-monthly report will be provided in early-2021.
- 7.2 The Chairperson and Deputy Chairperson presented the Board Plan to Councillors at Long Term Plan briefings on 15 September and 17 November 2020.
- 7.3 The presentations included an overview of why the outcomes sought in the Board Plan are important to the community and identification of where significant outcomes are not reflected in proposed levels of service.

8. Community Board Matters of Interest

8.1 **Board Meeting at Huntsbury Community Centre** – The Board held its 1 December 2020 meeting at Huntsbury Community Centre to get out into the community and be more accessible to people. Before the meeting, the Board had a tour around the Centre to see what has been done to make it earthquake proof.



8.2 **Predator Free Port Hills** – The Summit Road Society thanked the Board for granting it \$45,000 in 2018, which helped to catalyse Predator Free Port Hills, a backyard trapping initiative in the urban fringe surrounding the Port Hills and Lyttelton Harbour. The vision is: "To protect native species and to see their populations flourish in our lifetime. Ultimately, we want the Port Hills to become predator free with thriving native wildlife in our neighbourhoods, local parks and reserves, farmland and bush areas."

1. Purpose of Report / Te Pūtake Pūrongo

The purpose of this report is to provide the Council with an overview of Part A matters requiring a Council decision and of initiatives and issues considered by the Community Board.

2. Community Board Recommendations

That the Council:

1. Receive the Community Board report for November and December 2020.

3. Community Board Decisions Under Delegation

The Te Pātaka o Rākaihautū / Banks Peninsula Community Board held meetings on 16 November, 30 November and 7 December. Decisions made under delegation were:

- Selwyn Road the Board approved No Stopping restrictions on Selwyn Road, Lyttelton.
- **Ross Terrace and Selwyn Lane** the Board approved No Stopping restrictions on Ross Terrace and Selwyn Lane, Lyttelton.
- **Seafield Road** the Board approved the installation of a P5 Loading Zone restriction on Seafield Road, adjacent to the Duvauchelle Slipway.
- **Banks Peninsula Libraries** the Board received an update on the activities of libraries on Banks Peninsula.
- **Akaroa Health Centre** the Board received an update on the targeted rate for the Akaroa Health Centre.
- Naval Point-Te Nukutai o Tapoa Development Plan the Board approved the Naval Point-Te Nukutai o Tapoa Development Plan 2020, including authorising the Manager Property Consultancy to enter into leases with the Canterbury Coastguard and Scouts New Zealand (Lyttelton Scout Group).

The Board also requested that staff initiate and progress a leasing plan for all other users of Naval Point, prioritising users that need certainty of tenure for fundraising or to be able to progress their plans. It was also noted that staff will be producing an operational plan for the Naval Point Development.

- **Rue Balguerie Proposed Parking Restrictions** the Board approved P120 and No Stopping Parking Restrictions for Rue Balguerie, Akaroa.
- **Stoddart Cottage Lease** the Board approved a lease for Stoddart Cottage, Diamond Harbour, to the Stoddart Cottage Trust, for a maximum term of 33 years.

- Kukupa Reserve Retaining Wall the Board approved the location and construction of a retaining wall at Kukupa Reserve, Pigeon Bay.
- **2021 Meeting Schedule** the Board adopted its Meeting Schedule for 2021 setting 20 meetings for the year, each to be followed by a Briefing.
- **Recess Committee** the Board appointed a Recess Committee to meet if necessary over the Christmas / New Year break.
- **Community Funding** the Board approved a grant of \$4,000 from its 20-21 Discretionary Response Fund to Te Puna Auaha Lyttelton Trust Board towards a mural project.

4. Part A Recommendations to Council

The following reports presenting Part A recommendations from the Board have been, or will be, considered by the Council:

- 4.1 Naval Point-Te Nukutai o Tapoa Development Plan (Closure of Magazine Bay Marina).
- 4.2 62 Archdalls Road, Duvauchelle Structures on Roads Proposal.

The Board's consideration and recommendation of the above reports will be considered by the Council at its meetings on 28 January 2021 (4.1) and 11 February 2021 (4.2).

5. Significant Council Projects in the Board Area

5.1 Head to Head Walkway

This project is to provide/construct a walkway around Lyttelton Harbour from Godley Head to Adderley Head.

Consultation on the route between Orton Bradley Park and Charteris Bay was undertaken during February/March 2019, the Community Board have approved one section of the route between the Charteris Bay Yacht Club and Paradise Beach. Staff are working closely with the local residents to determine the best route option between Orton Bradley Park and Paradise Beach. Staff are also working on sections of track upgrades, signage and route options for the rest of the Head to Head route.

5.2 Akaroa Wharf Renewal

The renewal of the Akaroa Wharf considers the replacement of the existing wharf and requires careful consideration of functional requirements, heritage and community inputs. Engineering reports have confirmed the need for a full wharf replacement in the near future.

A Multi Criteria Analysis (MCA) and Engineering Options and Needs Assessment report has been prepared to support decision making and consultation. The MCA includes a thorough review of issues and opportunities associated with the location and materials for the new wharf and is supported by high-level budget estimates for each option.

A needs assessment and user requirements report has also been prepared to support budget and planning and recognises the need for the retention of the existing length of the structure due to its tidal nature and the commercial use of the wharf by a number of commercial fishing and tourism operations.

Staff are currently working through the planning and future for the existing and privatelyowned buildings on the wharf and once this has been developed staff will take a report to the Executive Leadership Team, the Council and the Community Board and then out for community consultation in early 2021.

 - **Community Flagpole French Farm** the Board agreed to support the proposal to install a flagpole on road reserve at French Farm for commemorative events, as presented, and requested that staff work with the applicants on any necessary procedures, including consultation with mana whenua.

7. Progress Report Against the Community Board Plan

1. Banks Peninsula Community Board Recommendation to Council

(Original officer recommendation accepted without change)

Part A

That the Council:

- 1. Notes this structure is inconsistent with the Structures on Roads Policy 2020
 - a. The inconsistency is as follows:
 - i. Section 1.2 Policy Scope second paragraph states that habitable structures are excluded from this policy.
 - ii. The current encroachment of the unformed legal road is part of the habitable structure on 62 Archdalls Road and this section consists of a bedroom.
 - b. The reason for the inconsistency is the encroachment on the unformed legal road of a bedroom extension as part of the adjacent house (a habitable structure) identified as 62 Archdalls Road (see Attachment A).
 - c. There is no intention to amend the Policy to allow habitable structures to encroach on the legal road reserve.
- 2. Approve the application to encroach on the legal road at 62 Archdalls Road, Duvauchelle authorised as shown in Attachment A, which consists of an extension of this premises.
- 3. Approve the granting of a Deed of Licence to allow the encroachment on the unformed legal road at 62 Archdalls Road for the term of 35 years or if the property is sold. A Deed of Licence (time limited) could be issued to future owners of 62 Archdalls Road, subject to an application once the property has been sold.
- 4. The Deed of Licence will also be subject to:
 - a. Reassessment if the structure is reconstructed (including due to seismic activity and/or coastal erosion) which will trigger a requirement to remove the part of the building encroaching onto the legal road.
 - b. Public access must be available passing the building for a future walkway scenario on the legal road; that may include use of the dwelling's driveway.
 - c. The public's right of access and lawful use of the legal road must not be obstructed by the structure's owners.

- d. If the site is affected by coastal cliff erosion and/or future seismic activity the Council will not be responsible for further erosion of the cliff within the legal road or to retain or repair the structure.

1. Purpose of the Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is to recommend to the Council the issuing of a deed of licence to confirm the occupation of part of an unformed road at Robinsons Bay. This report has been written following an application for a deed of licence in respect of the encroachment of the unformed road at 62 Archdalls Road; see Attachment A for the survey plan.
- 1.2 The decision in this report is of low significance in relation to the Christchurch City Council's Significance and Engagement Policy. The level of significance was determined by the low level of impact for the wider district and the negligible number of people affected by the recommended decision. There has been no wider community engagement and consultation reflected by the assessment.

2. Officer Recommendations / Ngā Tūtohu

That the Te Pātaka o Rākaihautū/Banks Peninsula Community Board recommends that the Council:

- 1. Notes this structure is inconsistent with the Structures on Roads Policy 2020
 - a. The inconsistency is as follows:
 - i. Section 1.2 Policy Scope second paragraph states that habitable structures are excluded from this policy.
 - ii. The current encroachment of the unformed legal road is part of the habitable structure on 62 Archdalls Road and this section consists of a bedroom.
 - b. The reason for the inconsistency is the encroachment on the unformed legal road of a bedroom extension as part of the adjacent house (a habitable structure) identified as 62 Archdalls Road (see Attachment A).
 - c. There is no intention to amend the Policy to allow habitable structures to encroach on the legal road reserve.
- 2. Approve the application to encroach on the legal road at 62 Archdalls Road, Duvauchelle authorised as shown in Attachment A, which consists of an extension of this premises.
- 3. Approve the granting of a Deed of Licence to allow the encroachment on the unformed legal road at 62 Archdalls Road for the term of 35 years or if the property is sold. A Deed of Licence (time limited) could be issued to future owners of 62 Archdalls Road, subject to an application once the property has been sold.
- 4. The Deed of Licence will also be subject to:
 - a. Reassessment if the structure is reconstructed (including due to seismic activity and/or coastal erosion) which will trigger a requirement to remove the part of the building encroaching onto the legal road.

- b. Public access must be available passing the building for a future walkway scenario on the legal road; that may include use of the dwelling's driveway.
- c. The public's right of access and lawful use of the legal road must not be obstructed by the structure's owners.
- d. If the site is affected by coastal cliff erosion and/or future seismic activity the Council will not be responsible for further erosion of the cliff within the legal road or to retain or repair the structure.
- 5. The annual fee will be set at the charge for a single garage on the legal road; currently \$207 which is reviewed annually.

3. Reason for Report Recommendations / Ngā Take mō te Whakatau

- 3.1 Although this encroachment has been in place since the consenting approval by the former Akaroa County Council the Council was approached by the owners' lawyers in August 2020 to resolve this anomaly. The recommendations will regulate this issue and provide the owners with certainty particularly if they sell the property. A deed of licence will also help if an insurance claim is made for damage or destruction.
- 3.2 The proposed deed of licence will also ensure that the public's right of access to the legal road is upheld.
- 3.3 The options in this report have been considered within the Council's legal powers and the legislative framework.
- 3.4 The report's recommendations do not provide any certainty that other habitable structures on the legal road will be licenced.

4. Alternative Options Considered / Ētahi atu Kōwhiringa

- 4.1 Four options have been reviewed including the scenario outlined in the recommendations. Those rejected are:
 - 4.1.1 **Do Nothing –** which would leave the situation unchanged, but would likely impede a future sale of the property and negatively impact on any future insurance claims.
 - 4.1.2 **Road Stopping –** this would legally convert the road land to freehold fee simple which could then be sold to the property owners. This is an expensive and time consuming process and the Council cannot guarantee a favourable outcome. Furthermore S345(3) Local Government Act 1974 means a successful road stopping adjacent to a large body of water (e.g. Robinsons Bay) keeps the land vested to the Council as Esplanade (Local Purpose) Reserve. The land in question could only be sold if were to be declassified as a reserve which is also another lengthy and expensive process.
 - 4.1.3 **Remove the encroaching structure –** as past cases (i.e. Angels Rest and the Taylors Mistake Baches) have been controversial this is not a desirable outcome. This option is expensive and time consuming, and could negatively impact on the Council's reputation.

5. Detail / Te Whakamahuki

5.1 There has been no community consultation on this matter as the encroachment has been in place since 1980. Although the site is legal road available for public passage it is understood that due to the cliff it is difficult to access and is rarely if ever used as a walking track; see the photos provided by the applicant's lawyers in Attachment B.

- 5.2 Staff are not aware of any complaints from the public about this building encroaching onto the legal road. Nevertheless, members of the public could exercise their right to speak about this report at the Community Board's meeting.
- 5.3 The decision affects the following wards/Community Board areas:
 - 5.3.1 Banks Peninsula Ward
 - 5.3.2 Te Pātaka o Rākaihautū/Banks Peninsula Community Board

6. Policy Framework Implications / Ngā Hīraunga ā- Kaupapa here

Strategic Alignment / Te Rautaki Tīaroaro

- 6.1 This report does not support the Council's strategic priorities as it is a minor issue.
- 6.2 This report does not support the <u>Council's Long Term Plan (2018 2028)</u>.

Policy Consistency / Te Whai Kaupapa here

- 6.3 The decision is inconsistent with Council's Plans and Policies namely the Structures on Roads Policy 2020 which does not permit habitable structures on the legal road.
- 6.4 Section 80 Local Government Act 2002 allows the Council to make decisions that are significantly inconsistent with any policy such as with this matter.
- 6.5 The rationale behind this proposed inconsistency is to manage the currently unauthorised encroachment on the legal road reserve and preserve the public's right of access.
- 6.6 In making an inconsistent decision the following must be identified:
 - 6.6.1 The inconsistency which is identified above.
 - 6.6.2 The reasons for the inconsistency the Structures on Roads policy does not permit habitable structures to encroach onto the legal road reserve under any circumstances.
- 6.7 There is no intention to amend the Policy to accommodate the decision. Any future applications will be considered on a case by case basis only.

Impact on Mana Whenua / Ngā Whai Take Mana Whenua

- 6.8 The decision does not involve a significant decision in relation to ancestral land or a body of water or other elements of intrinsic value, therefore this decision does not specifically impact Mana Whenua, their culture and traditions.
- 6.9 Although the site is adjacent to Robinsons Bay which forms part of Akaroa Harbour the building's extension on the legal road was approved in 1980 and is therefore of minor significance. There has been no engagement with Ngai Tahu on this matter.
- 6.10 Staff have reviewed the Mahaanui Kurataiao Iwi Management Plan in respect of Akaroa Harbour, and we have found there are no defined aspects or objectives within the Plan's framework in relation to this site.

Climate Change Impact Considerations / Ngā Whai Whakaaro mā te Āhuarangi

6.11 There are no climate change impacts arising from this decision.

Accessibility Considerations / Ngā Whai Whakaaro mā te Hunga Hauā

6.12 The decision does not restrict the publics' access to the legal road as the encroachment extends two metres from the property boundary and allows the remainder of the road reserve between three and five metres unobstructed along the cliff top (Attachment A). However, as mentioned above in the recommendations the key accessibility issue is the steep cliff face which acts as the main barrier (see Attachment B).

7. Resource Implications / Ngā Hīraunga Rauemi

Capex/Opex / Ngā Utu Whakahaere

- 7.1 Cost to implement Zero the costs for the application process and the deed of licence are paid by the applicant.
- 7.2 Maintenance/Ongoing costs Zero as the applicant is responsible for maintenance and the other ongoing costs of the structure.
- 7.3 Funding Source the applicant pays the Council's costs.

Other / He mea anō

7.4 There are none.

8. Legal Implications / Ngā Hīraunga ā-Ture

Statutory power to undertake proposals in the report / Te Manatū Whakahaere Kaupapa

8.1 Section 80 Local Government Act 2002 allows the Council to make decisions that are significantly inconsistent with any policy such as in this matter, see section 6 for further details.

Other Legal Implications / Ētahi atu Hīraunga-ā-Ture

- 8.2 There is no other legal context, issue or implication relevant to this decision.
- 8.3 This report has not been reviewed and approved by the Legal Services Unit.

9. Risk Management Implications / Ngā Hīraunga Tūraru

- 9.1 There is unlikely to be any significant risks resulting from this decision, largely because the encroachment has been in place for many years and has not led to any complaints. Additionally the building's extension does not fully obstruct the legal road and this area is already difficult to access safely (Attachments A & B).
- 9.2 The staff recommendations include a time limit for the licence (within the limits outlined in the Resource Management Act 1991 S218(1)(a)(iii) to avoid sub-dividing the site) to ensure that future action can be taken if the house is to be reconstructed. At that time the Licence to occupy the legal road would be revoked.





15. Chairperson's Report: Representation on Coastal Hazards Working Group

1. Purpose of Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is to present to Council the recommendations of the Coastal Hazards Working Group (CHWG) on whether membership of the CHWG should increase.
- 1.2 The CHWG has no decision-making powers but, in accordance with its delegation, has considered the issue of increasing its membership, including representation from Community Boards, and is now making recommendations to the Council.

2. Chairperson's Recommendations

That the Council:

1. Endorse the approach for membership and representation on the Coastal Hazards Working Group, as set out in this report, specifically, that membership of the Working Group is not increased at this time.

Note: the Working Group intends to invite the chair or delegate of a Community Board to participate in the Coastal Hazards Working Group for the duration of consultation in their community.

3. Detail / Te Whakamahuki

- 3.1 The Coastal Hazards Working Group was formed by Council resolution on 13 August 2020.
- 3.2 On 10 September 2020 Christchurch City Council resolved (CNCL/2020/00106):

"That the matter of increased membership, including representation from Community Boards, of the Coastal Hazards Working Group be referred back to the Working Group to report back to the Council."

- 3.3 The Coastal Hazards Working Group Terms of Reference authorise the Working Group to invite additional members from parties comprising the Greater Christchurch Partnership¹ partners, including individuals from Community Boards.
- 3.4 Members from Ngai Tahu, Environment Canterbury, Waimakariri District Council, and Selwyn District Council have accepted invitations to join the Working Group.
- 3.5 There are currently fourteen (14) representatives in the Working Group comprised of:
 - 3.5.1 Eight (8) elected members from Christchurch City Council;
 - 3.5.2 Two (2) elected members from Environment Canterbury;

¹ The Greater Christchurch Partnership comprises of: Christchurch City Council, Environment Canterbury, Selwyn District Council, Waimakariri District Council, Te Rūnunga o Ngāi Tahu, New Zealand Transport Agency, Canterbury District Health Board, Greater Christchurch Group – the Department of Prime Minister and Cabinet and Regenerate Christchurch.

- 3.5.3 One (1) representative for Ngai Tahu
- 3.5.4 One (1) staff member of Christchurch City Council as proxy until a second Ngai Tahu representative is selected by Rūnunga.
- 3.5.5 One (1) elected member from Selwyn District Council (as observer)
- 3.5.6 One (1) elected member from Waimakariri District Council (as observer)
- 3.6 The elected members of Christchurch City Council are also members of five (5) Community Boards (Banks Peninsula, Coastal-Burwood, Linwood-Central-Heathcote, Papanui-Innes, and Spreydon-Cashmere).
- 3.7 On 16 September 2020 the Christchurch City Council elected members met to discuss increasing the membership of the Working Group.
- 3.8 The Working Group does not recommend increasing the membership of the Working Group at this time. Rather, the Working Group proposes to invite the chair or delegate of a Community Board to participate as a member of CHWG for the duration of consultation in their community.
- 3.9 Some of the matters discussed by the Working Group are as follows:
 - 3.9.1 It is important to obtain and listen to feedback from each community during the Coastal Hazards Adaptation Planning (CHAP) programme.
 - 3.9.2 The CHAP programme of work is complex and will be addressed over an extended period of time. The Working Group expects to meet monthly throughout 2021.
 - 3.9.3 The CHWG engagement strategy is being informed by Royal Haskoning DHV who encourage engagement with affected communities in stages, rather than a city-wide conversation.
 - 3.9.4 Increasing the membership of the Working Group will detrimentally impact on its functional and operational effectiveness. Inviting an individual from each Community Board would increase membership of the CHWG to twenty one (21) members.
 - 3.9.5 Working Group meetings are currently two hours, increasing the membership will limit the ability for each member to participate meaningfully.
 - 3.9.6 A large working group supplemented by staff will reduce the number of suitable venues to hold a meeting and diminish the effective provision of guidance by the Working Group to Council staff.
 - 3.9.7 It was widely anticipated there would be an expectation for information to be relayed by a person attending a Coastal Hazards Working Group back to the Community Board. The Working Group supports the Combined Community Board Briefings as a more direct and suitable channel to inform Community Boards about progress of the CHAP programme.
 - 3.9.8 During the CHAP programme a Coastal Panel will be formed for each adaptation area. A Coastal Panel will be comprised of community representatives, which community board members will have an opportunity to be involved in.
- 3.10 Following discussions the Working Group agreed to not increase the membership of the Working Group.
- 3.11 The Working Group noted that it intends to invite a chair (or delegate) to participate in the Working Group while their community was being consulted.
