4.2 Otukaikino Healthy Waterways and Catchment Collaborative Partnership - Update

Mike Patchett, Chairperson, Water & Wildlife Habitat Trust, addressed the Board regarding the Otukaikino Healthy Waterways and Catchment Collaborative Partnership.

 - b. The south side of Teesdale Street, commencing at its intersection with Deepdale Street and extending in an easterly direction for a distance of 12 metres; and,

Kia ora,

My name is Liam Stretch, a resident on Staveley Street, Avonhead. I am a 24-year-old journalist and a genuine advocate for my city. I see what Ōtautahi is and what it can be. With that being said, I don't normally voice my concerns until there is a great need for change.

After years of relegating this to the category of 'minor priority' as there were areas of the city that needed development more than the north-west, we as a community have decided to now raise this up in our radar as many a resident is at their wit's end, and are gravely concerned for the safety of themselves and their children.

Our concern pertains to the safety on Staveley Street and surrounding areas. It is the main thoroughfare connecting Avonhead and Withells Roads, and understandably, has a regular flow of traffic. The issue that concerns many of us is the constant high speeds – one resident clocked someone driving 90 kmh down the street – and the regular burnouts that are permitted because of the shape of the wide intersections. It is also a bus route for the 130 – this has even been clocked at 65kmh.

Usually, I would be able to forgive such activity. It regularly stems from a lack of things to do for young people – a gap I endeavoured to fill during my tenure on the Christchurch Youth Council. But this is excessive and could lead to death as the street is also the main route for school children from Russley, Merrin and Avonhead primary schools. It is also home to Kidsfirst Avonhead Kindergarten, Avonhead Scout Den, Staveley Reserve, a block of shops which include a dairy regularly frequented by children, a fish and chip, takeaway, convenience store, and others. There is also churches and a tutoring service.

After talking to the kindergarten, I was informed that many parents and children have had close calls with cars to and from the grounds. Personally, I encountered a car do a burnout right in front of the kindergarten around the time many children were being picked up. A collision with a child has even occurred, according to one parent.

Police have been contacted several times and said they would patrol, but this has been short-lived and has made little impact.

After reaching out to residents on a community page, I found I was not alone in my concern. They're scared to let their children play with others down the street or at the local park, they're scared to let their pets out, they're scared when getting into their cars curb-side. We've had cars crash into the park fence, and skid into the other lanes as they speed around the corner.

When you were elected, you promised to serve the community you represent to the best of your ability. You've collectively inherited a massive job, and I applaud you for your dedication to this little city of ours. But I am imploring you here – please look into this; otherwise, we may have an undue death on all our hands. I know not many 24-year-olds take the time to write such letters, but I really wouldn't want anything bad to happen on my childhood street due to neglect.

Other residents and I have discussed what we would see as a positive change:

- The consideration of traffic management.

- Speed limit signs.
- Speed bumps that would be still fine for a bus to use (we know this is possible when we look at the new road layout of Ilam Road).
- A pedestrian crossing from left to right in front of the Kidsfirst Kindergarten.
- Some road islands to add further safety.

Thank you for reading this. I understand the complexity of your job and the tough road ahead managing funds in this current time, but as it is approaching Christmas and summer is nipping at our heels, the street will be busier, people will be enjoying the season, and if we do not address this problem, someone will get hurt, and my conscience would not sit right if I stood by and did nothing.
