4.1 Cycle Safety

Sophia White, resident, spoke about concerns with cycle safety in the Board area.

Ms White proposed an idea of running a bumper sticker design competition in schools. The sticker could then be printed and put on parents' cars and shared amongst community to build awareness of cycle safety.

4.2 King George V Reserve

Mark Gibson, resident, spoke about the forthcoming 30th anniversary celebration for King George V Reserve to acknowledge the launch of a community-led regeneration project in 1990. At the event, he will also seek expressions of interest for volunteers to help with reserve.

Mr Gibson noted that he might apply for a small grant to support this event. He would also like an elected member to speak at the celebration to represent the Council.

Mr Gibson noted that many residents would like the reserve to be renamed to create a closer connection to the community.
