Mr Hamilton also raised the issue of freedom campers and the vehicles that he believed were clearly not self-contained, parking in the designated area in Akaroa. He was advised that the Freedom Camping Bylaw was due for review with public consultation in May-June this year.

12.1 Moepuku Peninsula - Harvesting of Pine Trees

Community Board Resolved BKCB/2021/00028

The Board heard of concerns expressed by the local community and forestry professionals regarding the removal of pine trees on Moepuku Peninsula in Lyttelton Harbour, which many believe could cause unacceptable amounts of sedimentation in the harbour. In particular, the concerns related to whether the sedimentation plan for the activity is robust enough, what sedimentation controls will be in place, who would be monitoring the activity and mitigation for any effects that future land and slash slippage will have on the harbour.
