Executive Summary

The current Hagley Sports Centre (formerly known as the Horticultural Hall) is to be redeveloped into a multi-use sports centre, returning the building to its original recreational use (which was indoor cricket training, squash and golf). Whilst the new centre will predominantly cater for indoor cricket training, it has been sized to also accommodate netball, basketball, hockey and futsal training and playing. It accommodates ancillary workspace and meeting space to support the training and community function. The focus of the centre is on community use.

The existing building is in a poor condition, has structural issues and its exterior fabric at the end of its useable life. The adhoc changes over time have resulted the current appearance of the building being unsightly and tired. The design process has reviewed a number of options around retention of the building, or large portions of it, right to full replacement.

The preferred option is demolition above grade, whilst retaining the existing slab and foundations. A new 400mm concrete raft foundation is to be poured over existing floor and foundations. Whilst providing additional seismic resilience to the new structure this also raises the floor level above the recently increased minimum floor level in the flood management area, in which this building sits.

The redeveloped building remains within the leased area. The total gross floor area of the redeveloped building is approx 40sqm less than the current building, with a slight increase in footprint (i.e. ground floor area) of 90sqm (7%)

A key aspect of the proposal is providing changing rooms which not only cater for the sports centre's use but is accessible directly from the exterior. This means these changing facilities can be utilised by the community using the sports fields of South Hagley Park, both during the week and weekends - including for school & regional competitions.

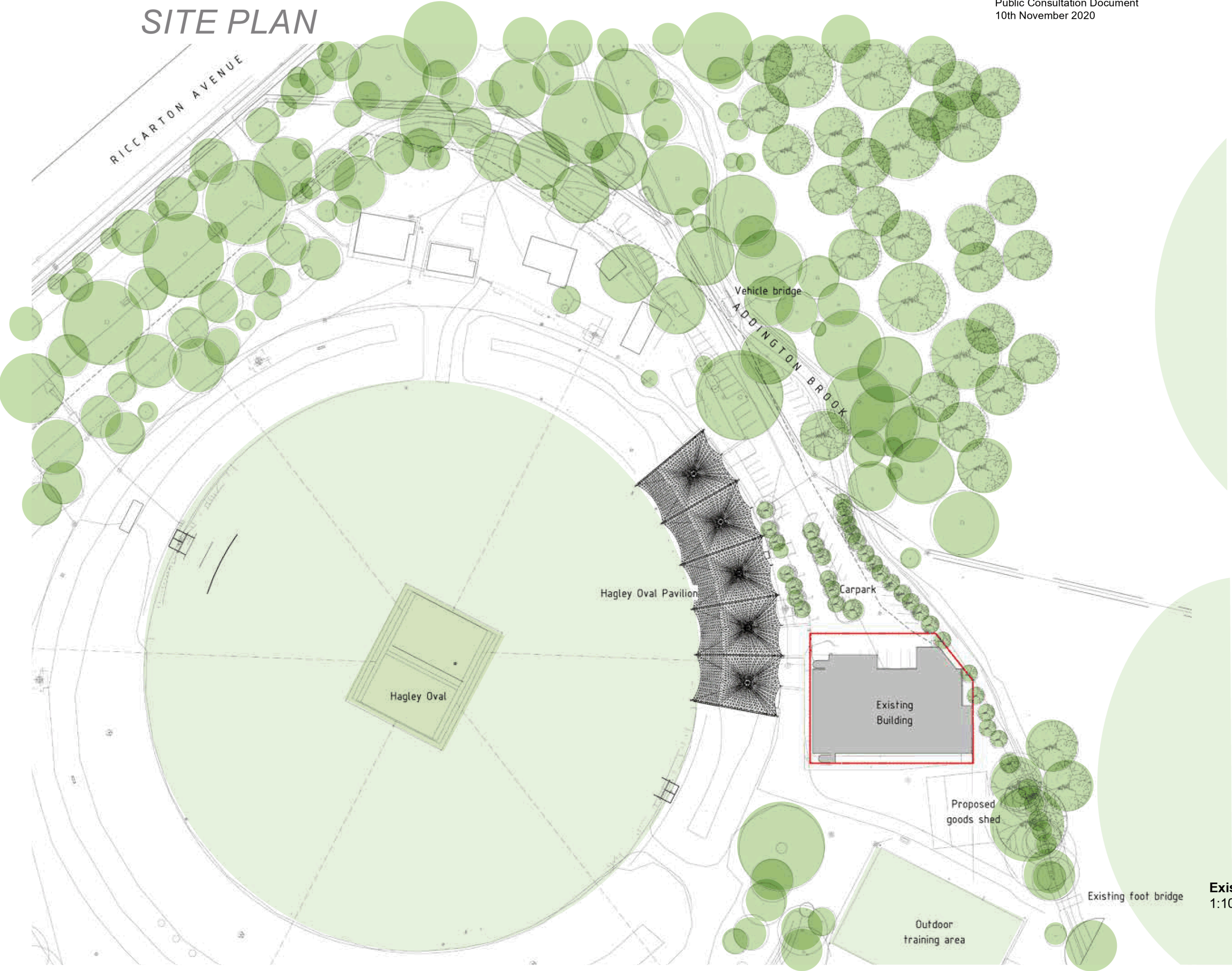

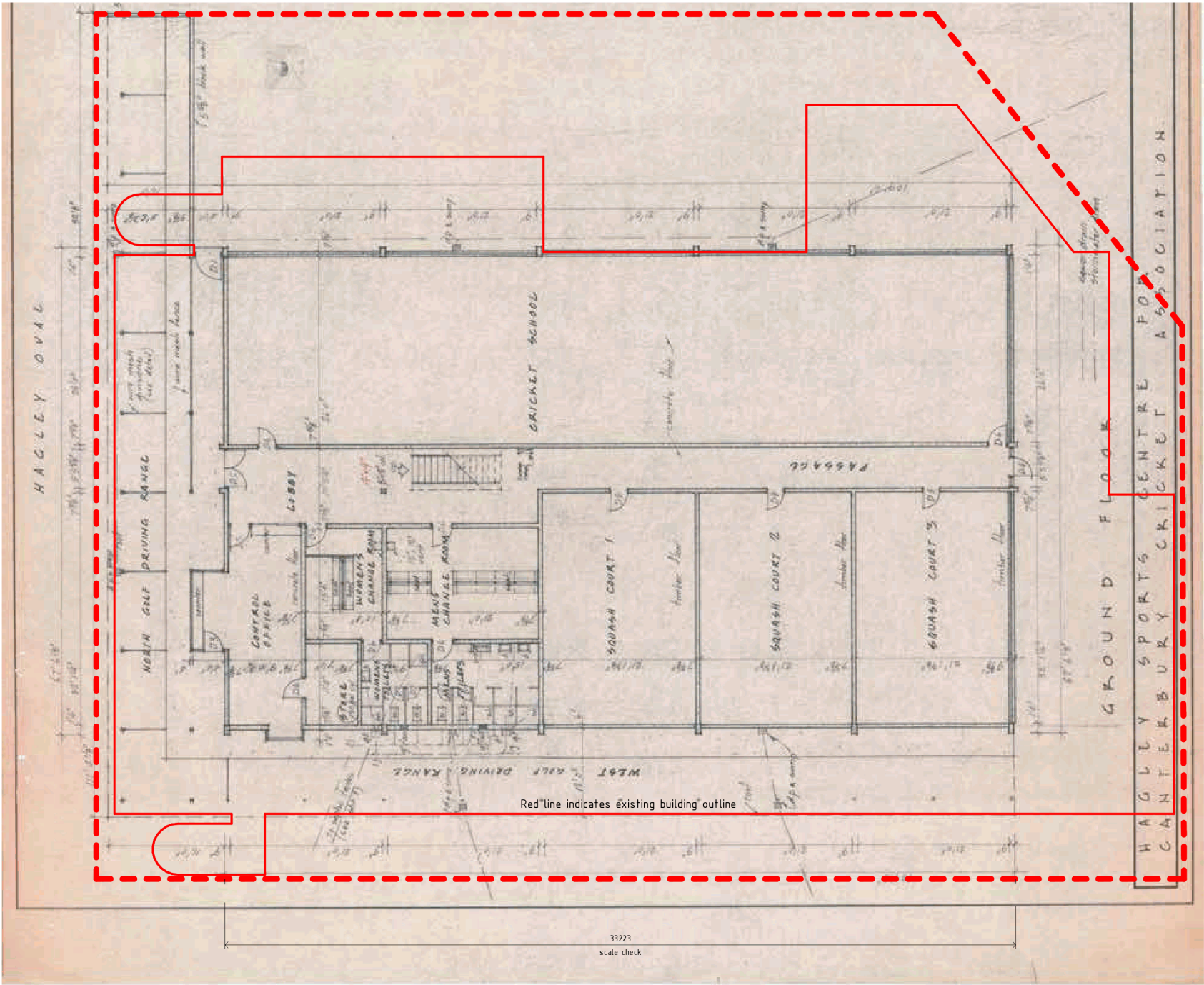


Existing Site Plan

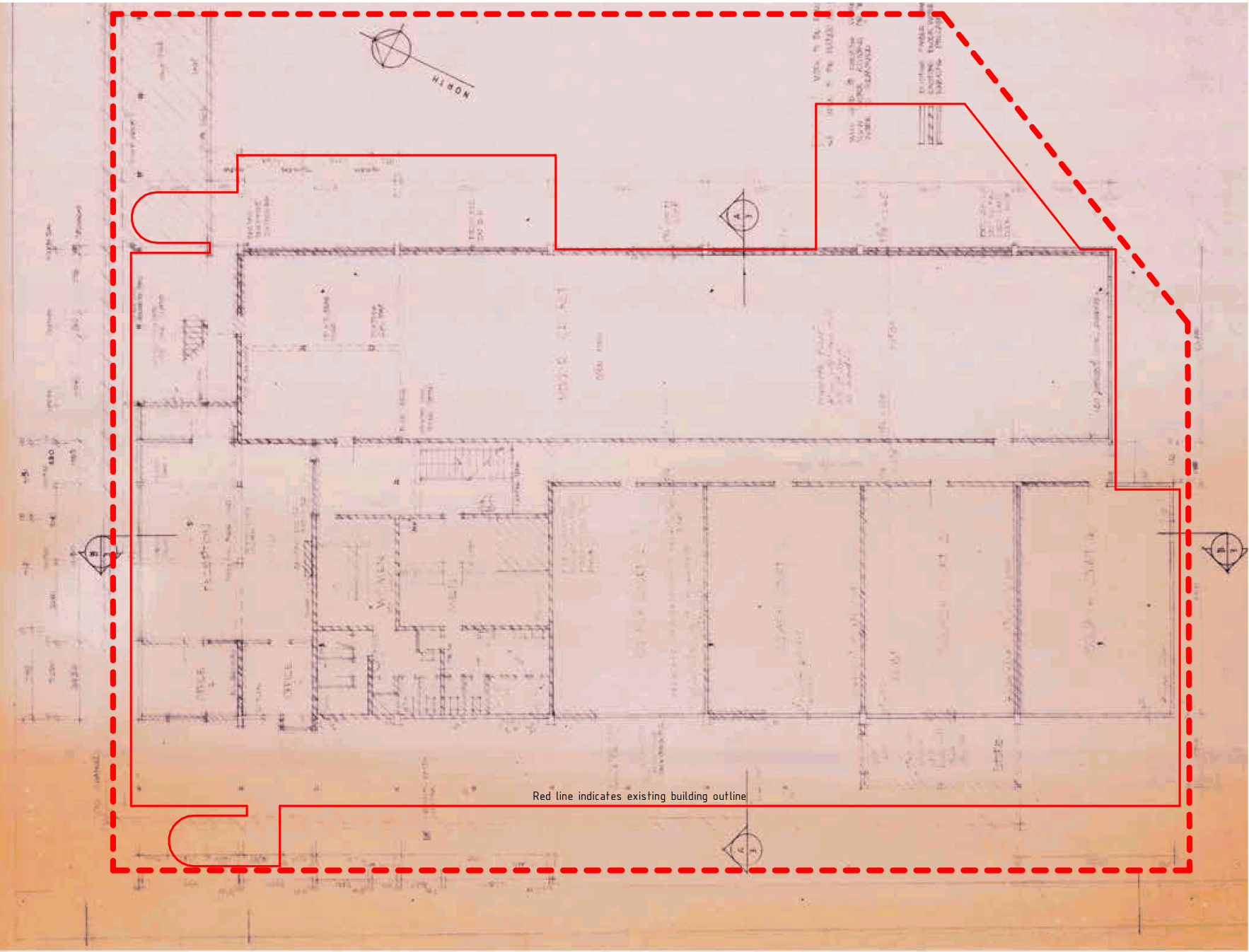

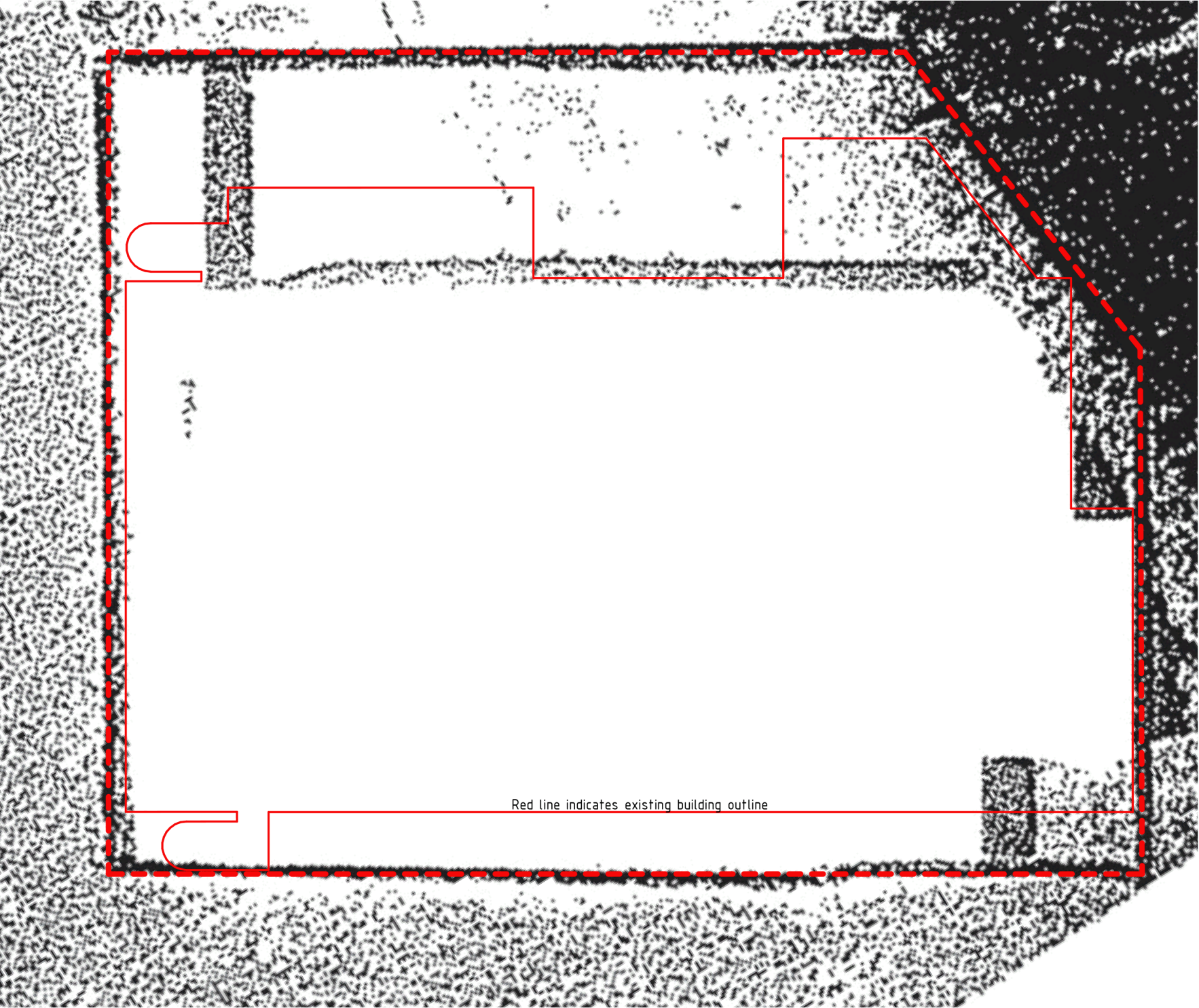

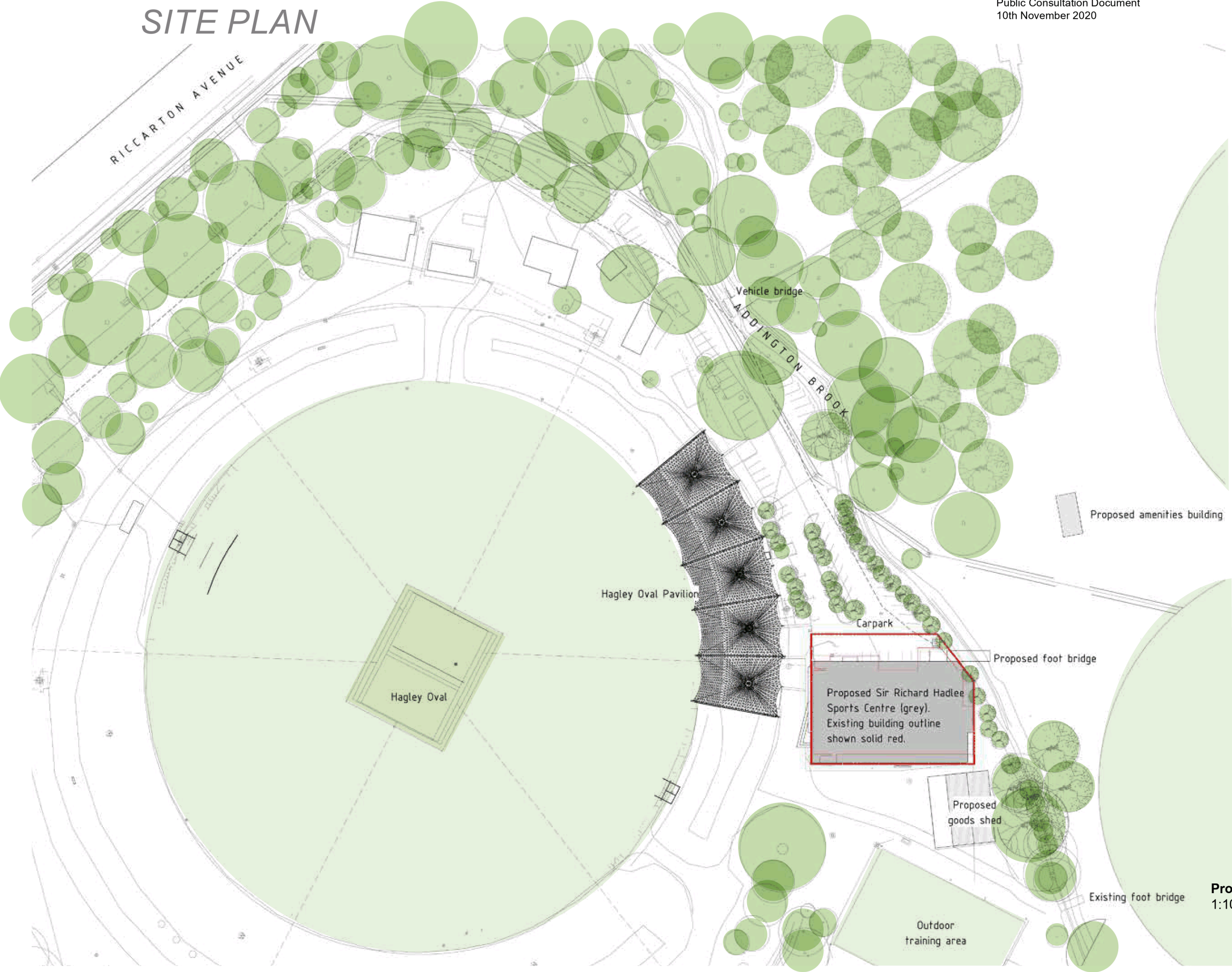

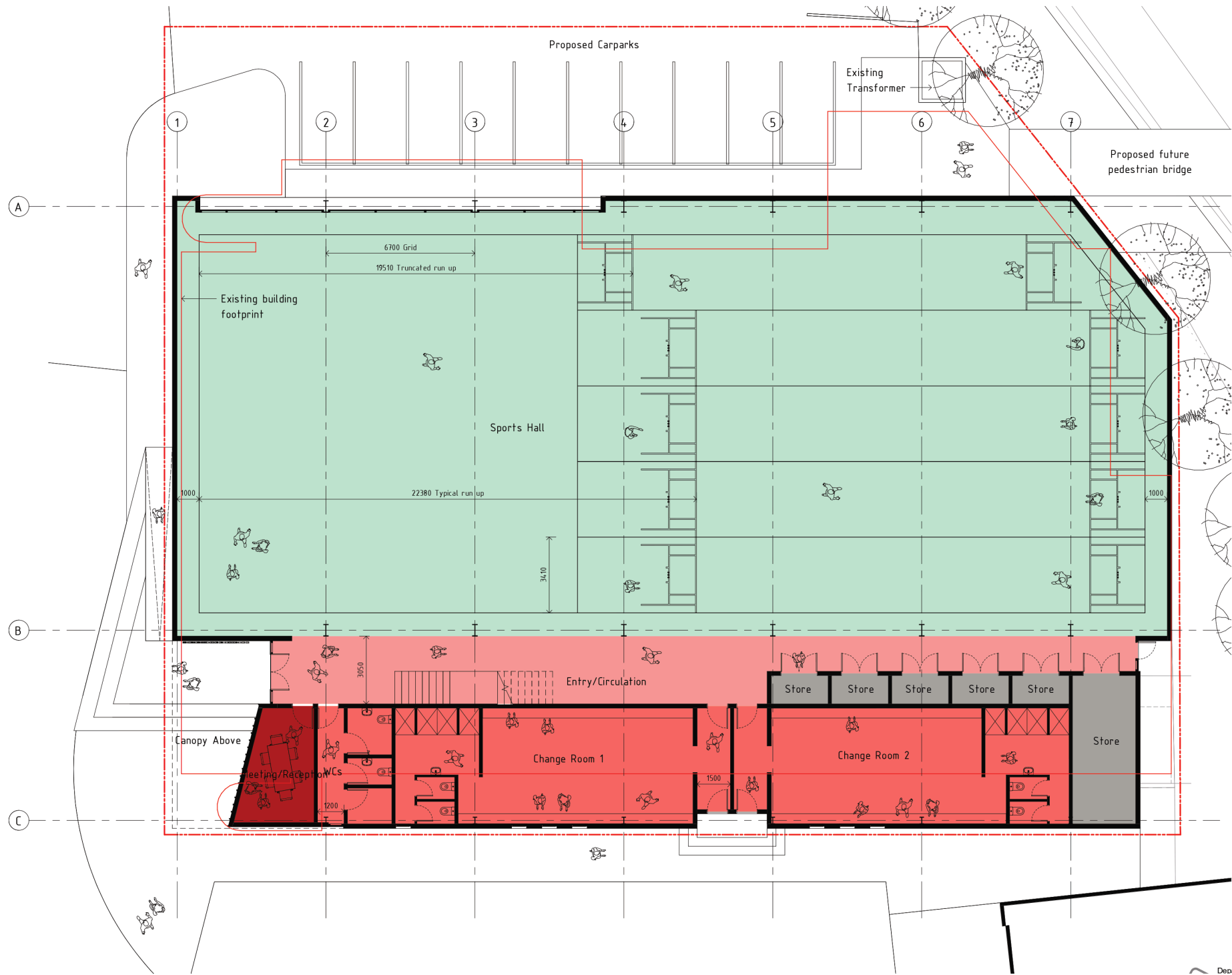


Proposed Site Plan

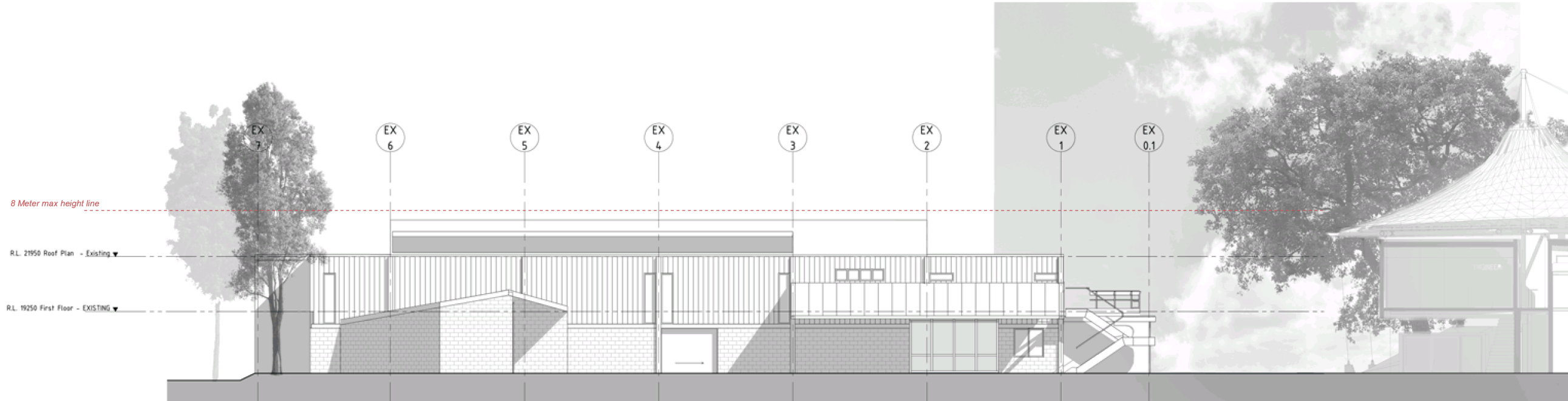

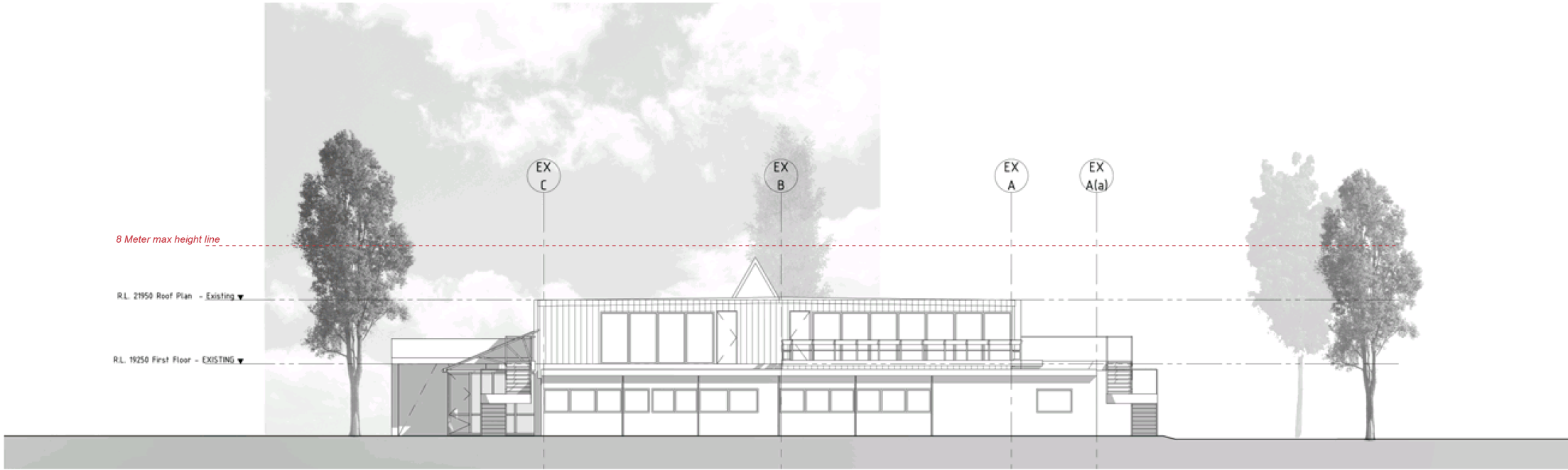


Proposed North East Elevation

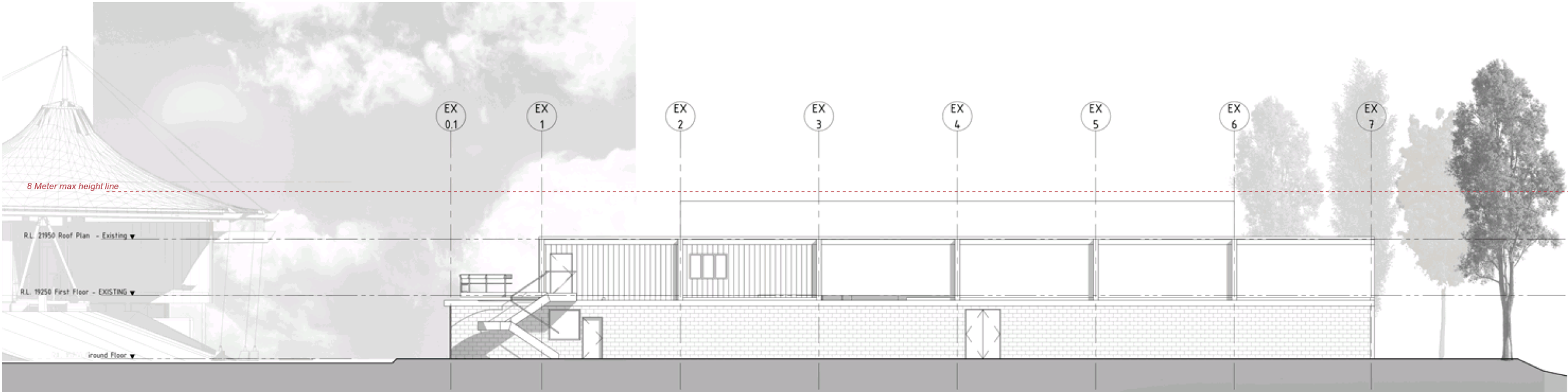


Proposed North West Elevation

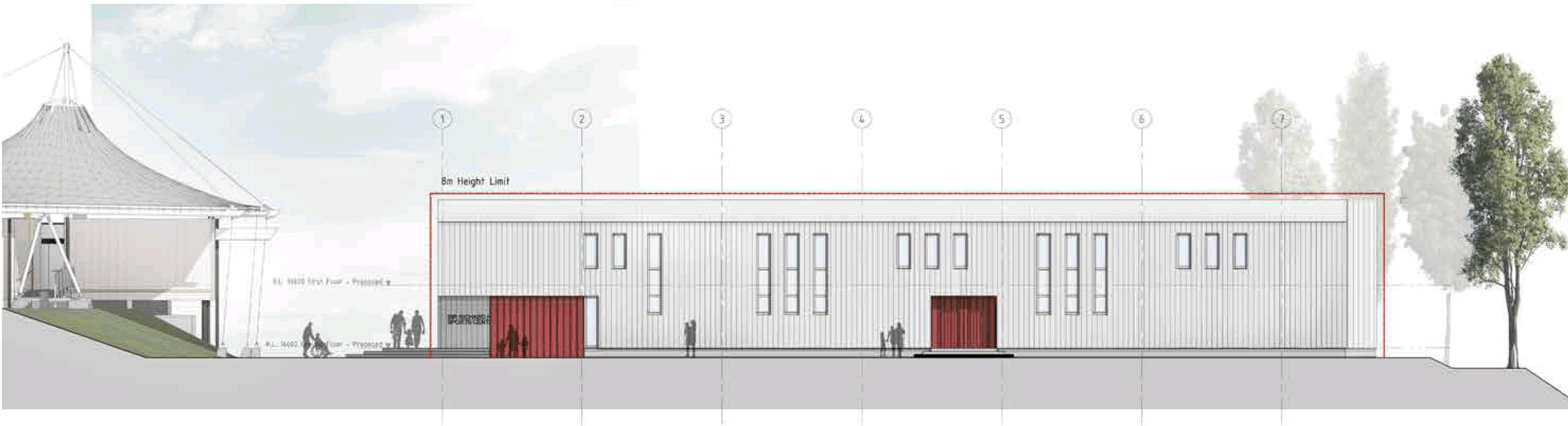
