

1. Purpose of Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is for the Waipapa/Papanui-Innes Community Board to approve the proposed road name at 27 Emprire Road in Bridgend.
- 1.2 This report is staff generated resulting from a naming request received from the subdivision developer.

2. Officer Recommendations / Ngā Tūtohu

That the Waipapa/Papanui-Innes Community Board resolve to:

- 1. Approve the following new road name for 27 Emprire Road (RMA/2018/2753):
 - a. Waimakariri Park Drive

3. Background / Te Horopaki

Introduction / Te Whakatkinga

- 3.1 A road naming request has been submitted by Davie Lovell-Smith Ltd on behalf of the developer, for the subdivision of 27 Emprire Road (RMA/2018/2753). A preferred name and alternative names have been put forward by the developer for the road.
- 3.2 The recommended road names have been checked against existing road names in Christchurch and bordering districts, for duplication, alternative spelling, or other similarities in spelling or pronunciation to avoid the potential for confusion. The proposed names are considered sufficiently different to existing road names.
- 3.3 The recommended road names have been checked against the Council's Roads and Right-of-Way Naming Policy dated 2 November 1993 and are considered to be consistent with this policy except as outlined below.
- 3.4 The recommended road names have also been checked against the Australia and New Zealand Standard AS/NZA 4819:2011 Rural and Urban Addressing. The names are considered to be consistent with the Standard unless otherwise stated below.
- 3.5 Under the Roads and Right-of-Way Naming Policy, the names considered must be requested by the developer. There is not an ability to consider alternative names without first checking whether there are any duplications or similarities with other road and right-of-way names.
- 3.6 Consultation has been undertaken with Land Information New Zealand who have raised no concerns with the proposed road names.
- 3.7 The names requested have been accompanied by an explanation of the background to the names, which is summarised below, along with correspondence with the applicant.

Assessment of Significance and Engagement / Te Aromatawai Whakahirahira

- 3.8 The decision in this report is of low significance in relation to the Christchurch City Council's Significance and Engagement Policy.
- 3.9 The level of significance was determined by the number of people affected and/or with an interest.
- 3.10 The Council's Senior Advisor Ngāi Tahu and Maori Relationships has been consulted and has raised no concerns with the suitability of 'Waimakariri Park Drive' (as set out below) as a road name.
- 3.11 Due to the assessment of low significance, no further community engagement and consultation is required.

Proposed Names

- 3.12 The location of the road is shown in **Attachment A**.
- 3.13 The proposed options are themed for the local environment.
- 3.14 The subdivision developer's preferred is Waimakariri Park Drive
- 3.15 Waimakariri Park is taken from the name of the development. The Waimakariri River is located nearby to the north and is one of the largest rivers in Canterbury. It flows for 151km from the Southern Alps across the Canterbury Plains to the Pacific Ocean.

Alternative Names

- 3.16 <u>Fanfare Drive</u> Fanfare is a sculpture located adjacent to the site. Fanfare by Neil Dawson is New Zealand's largest public sculpture and was installed in its current location in 2015. It is a six-storey-high sphere (20 metres in diameter and weighing 25 tonnes) covered in 1.5 metre steel pinwheel fans that can be illuminated in a spectrum of colours at night.
- 3.17 <u>Braided River Drive</u> The Waimakariri River is a prime example of a braided river. A braided river consists of a network of river channels separated by small, often temporary, islands. The channels and braid bars are usually highly mobile, with the river layout often changing significantly during flood events.



The Board recommends amending the wording to clarify the difference between a residents' exemption parking area, and a resident-only parking area.

The Waipapa/Papanui-Innes Community Board welcomes the opportunity to submit on the Wheels to Wings Major Cycleway project. In doing so, the Board notes that it has not yet heard the community's views on the proposal, but that information will be an outcome of this consultation. The result of the consultation might bring further issues to light, which the Board would need to consider.

The Waipapa/Papanui-Innes Community Board appreciates and supports the improvement that this project will make to the city's overall cycleway network.

The Board is pleased that the proposed route connects with the Northern Line and future Nor'West Arc routes, and provides an active travel link to the airport precinct and key activity centres.

The Board also appreciates that investment in active transport modes is a necessary response to the Council's declaration of a climate and ecological emergency, given the transport sector's significant contribution to the city's carbon emissions.

Noting the earlier comment regarding the need to consider the community feedback, at this stage the Board supports the following features of the proposal:

- The installation of turning arrows at the Greers/Harewood intersection.
- The connection to local schools, providing a safe cycling route for students.
- Traffic controls for Chapel Street and Sails Street to limit use of these streets for rat running through to Langdons Road.

Noting the earlier comment regarding the need to consider the community feedback, at this stage the Board has concerns about the following features of the proposal:

- The loss of on-street parking outside multiple rest homes. The on-street parking is used by workers at these facilities.
- The loss of on-street parking outside local businesses including Dove Bookshop, Strowan Law, Team Dental Papanui and the Harewood Medical Centre.

Based on the Board's experience relating to major roading projects in our Wards, the Board wishes to note the importance of team work with regards to enforcement, education, and monitoring of road users' behaviour. This relates specifically to the Christchurch City Council and the Police being able to ensure safety and compliance (within each organisation's remit) when this new development is in place.
