Good Afternoon Liz,

Can I request that the replanting by Kiwirail, on the completion of the Opawa Rail Bridge project is included for the meeting on May 12th? The request is for the Community Board to advocate for Kiwirail to add additional landscaping to the area around the Kiwirail structures on all surrounding areas on Clarendon and Richardson Terrace

Below is the approved consent which refers to the replanting and repair of the affected riverbanks. There may be other consents to include other landscaping, but I haven't been able to find any.

I have spoken to Rebecca Beale at Kiwirail last week and she will discuss with the Kiwirail Project Manager this week (he was away), if there is scope add more vegetation, outside of the consent.

I understand that there are limitations of being able to replace trees due to the clearance area. Anything that can be planted to break up industrial look of the concrete structure, would be of great benefit to the community from an aesthetic perspective, especially as this is a well utilised area.

I am aware there is a review after talking to affected residents to look at puttting some small trees behind the houses on Clarendon Terrace to minimise noise from the train.

Good Afternoon Liz,

Can I request that fixing of the footpath on Richardson Terrace under both the Heathcote Bridge and the Kiwirail Opawa Bridge is included for the meeting on May 12th?

The request is for the Community Board to advocate for the necessary consents to be granted from the CCC so that access is not continually affected by flooding after rain fall or king tides. Hopefully, this project can be approved in the next 3 months before Richardson Terrace is reopened now at the end of July 2021. I am happy to make a deputation.

This issue of flooding the foot path access has been ongoing and was highlighted due to the lack of road access because of the Kiwirail bridge project.

I am aware that Fulton Hogan can do this work with the required CCC approval, and I have spoken to CCC Roadside Maintenance Manager who has requested funding for a plan.

As this issue was raised to board members by Myself and others in November last year, it was hoped that the issue of the foot path flooding would be prioritised to be done before the road reopens.

I have been forwarded an email below regarding concepts but there is no clear start date.

Dear Liz

I would be glad if you could table our comments for the information of the Community Board when they discuss this issue further.

The RRA and SCRA wish to comment on the memorandum dated 29 March 2021 to the Waikura /Linwood-Centreal-Heathcote Community Board from Kirsty Mahoney, Project Manager Transport, regarding the update on the rocks on Clifton Beach. We feel this does nothing to advance the resolution of the problem.

Residents have been complaining to Council since August 2019 (before the works finished) about the presence of rocks left on Clifton Beach as a result of the works. After initial attempts to deny that there was any problem, the damage to the beach was acknowledged in a briefing by Council staff to the Community Board on 18 November 2019.

The Residents Associations asked for urgent action on 23 August 2020 when weather conditions had made the problem even worse, and were told by Lynette Ellis on 14 September 2020 that she was "evaluating further optionswhen we have further information that we can share we will let you know". This is the last communication we have received.

So far the only response appears to be an attempt to overturn ECan's determination of non compliance with their consent conditions, in particular condition 22 of CRC 183112. Council staff mention condition 16 of the consent. Condition 16 requires that material not reused on site be disposed of off-site at a facility authorised to receive such material. This is irrelevant to the need to deal with the loss of amenity caused by presence of the rocks at and near the surface of the beach, but would permit the unwanted material to be removed from the beach.

The technical report commissioned by CCC from Aurecon New Zealand Ltd confirmed that the rocks now visible on the surface of the beach are a mixture of rock types and debris, mainly basalt but including greywacke pebbles, concrete, clay pipework etc. This was consistent with the material visible in test pits dug before the start of the works. The presence of this material deep in the beach was therefore known to Council staff before the work commenced. It would have been possible to keep this separate from the overlying sand and to return it to the trench. During the works it would have been apparent to staff, as it was to residents observing the works, that this material was allowed to be mixed with the natural sand. The adverse result was clearly the responsibility of Council as staff did not even require the contractors to remove all the rocks greater than 100mm from the surface of the beach (as they had claimed) let alone take any effective steps to return the beach to its natural condition.

Observations of the beach over the past 18 months show that the surface sand is very mobile depending largely on the wind direction, and the current state of the beach is that the western end has an accumulation of sand covering the layer of rocks, reducing the nuisance to a very minor level, while the eastern end still has many rocks on the surface, ECan has recently determined (14 April 2021) that at present the loss of amenity is minor so that no action is currently required by them, but that "if the material is exposed again in a density that is again considered to negatively impact the amenity values then this grading may be changed to reflect that".

However the east end of the beach is currently affected by large numbers of surface rocks and there is a high likelihood that other material will again be exposed depending on wind and sea conditions.

The Residents Associations call on the Community Board to require Council staff to produce their plans for dealing with the problem, which is plainly Council responsibility. We have now had two summers when residents and visitors have not been able to enjoy the natural amenity of the beach as they had previously and we would like to see some constructive action.

1. Purpose of the Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is to adopt the Waikura/Linwood-Central-Heathcote Community Board Sustainability Charter. This report has been written to fulfil Strategic Initiative 9: Improve community resilience and preparedness for the impact of Climate Change, of the Waikura/Linwood-Central-Heathcote Community Board Plan 2020-2022.
- 1.2 The decision in this report is of low significance in relation to the Christchurch City Council's Significance and Engagement Policy.

2. Officer Recommendations / Ngā Tūtohu

That the Waikura/Linwood-Central-Heathcote Community Board:

1. Adopts the Waikura/Linwood-Central-Heathcote Sustainability Charter.

3. Reason for Report Recommendations / Ngā Take mō te Whakatau

- 3.1 In its deliberation about Board Plan Priorities, Board members considered that whilst Climate Change a matter of global and city-wide importance, the Linwood-Central-Heathcote Community Board area will be particularly affected by sea level rise and coastal inundation, and that their plan needed to reflect this.
- 3.2 Furthermore, the impacts of climate change will exacerbate the resilience, social, cultural and economic issues already being experienced by people in poverty in our Board area, so the Board wished to consolidate their support for and to enhance community and Council activity in this area of endeavour.
- 3.3 The Board determined to develop a sustainability plan/charter for the Linwood-Central-Heathcote Community Board area that clearly articulates the Board's commitments and priorities for action and encourages citizen participation.

4. Alternative Options Considered / Etahi atu Kowhiringa

- 4.1 The alternative that Board may consider, is not to adopt the plan and retain the status quo.
- 4.2 An advantage to not adopting the plan could be that Board makes no changes to its current commitments.
- 4.3 A disadvantage would be that the Board does not fulfil its Plan commitments to the community.



5. Detail / Te Whakamahuki

- 5.1 This Board priority was consulted on in 2020 during the development of the Community Board Plan.
- 5.2 The decision affects the all wards in the Linwood-Central-Heathcote Community Board area.

- 7.1 Cost to Implement no additional capital funding will be required to fulfil this charter, as it can be currently met through re-prioritising and achieving greater efficiency in operational budgets.
- 7.2 Maintenance/Ongoing costs it is expected that this charter can be fulfilled through prioritisation of current operational costs.
- 7.3 Funding Source Community Board Discretionary Response funding may become available for aligned community projects.

1. Purpose of the Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is to consider the request for a variation to the current lease held by The Green Effect Trust (the "Trust") on land adjoining Charlesworth Reserve (the Park) for the expansion of the Trees for Canterbury native plant nursery and construction of new buildings.
- 1.2 The Trust entered into a new lease with Council dated 13 January 2015 having a final expiry of 31 December 2024.
- 1.3 The variation would involve an increase of the current lease area into land currently used as open space. The increased lease area and new buildings would enable expansion of production of native plants and would benefit the environment by increasing the supply of eco-sourced and other plantings for public and private use.
- 1.4 The decision in this report is of low significance in relation to the Christchurch City Council's Significance and Engagement Policy. The level of significance was determined by considering the number and impact on those affected. Although the reserve is popular and the proposal reduces the opportunity for public use, the remaining land available is considered sufficient for existing public use requirements.

2. Officer Recommendations / Ngā Tūtohu

That the Waikura/Linwood-Central-Heathcote Community Board:

- 1. Grant a variation of the lease dated 13 January 2015 to The Green Effect Trust for the Council property at 54 Charlesworth Street.
- 2. Grant a variation to include that area of land being approximately 2978 square metres and part of the land described as RS41637, as shown 'K' on the plan in Attachment A.
- 3. Approve the construction of a new shade house building, crop cover building and perimeter fencing within the lease are as shown on the plan in Attachment A.
- 4. Authorise the Manager Property Consultancy to conclude and administer the terms and conditions of the lease variation.
- 5. Note that the lease is subject to The Green Effect Trust meeting all regulatory requirements including those of the Building Act 1991 and the Resource Management Act 1991.

3. Reason for Report Recommendations / Ngā Take mō te Whakatau

3.1 The expanded production opportunity will provide environmental benefit through increased plant supply and also social benefit through increased opportunities for disadvantaged

people to work in the nursery. The nursery is a significant contributor to Council revegetation projects, both through purchase and donation of plants, and to community projects.

3.2 The proposal has an impact on the use of adjoining open space by reducing its size. The visual impact has been minimised through the retention of existing on site vegetation and the intention to replant the screening vegetation outside the proposed lease fence line. The loss of space is considered reasonable taking in to account the amount of space to be retained for public use.

Alternative Options Considered / Etahi atu Kowhiringa

- 3.3 Alternative option 1 No variation to the lease.
 - 3.3.1 Advantages The area of Charlesworth Reserve requested for the lease variation will remain as public open space.
 - 3.3.2 Disadvantages Native plant production will not be able to be increased, with fewer plants available for Council and community projects, and fewer employment opportunities for disadvantaged members of the community.
- 3.4 Alternative option 2 A reduced lease variation area.
 - 3.4.1 Advantages A smaller area of Charlesworth Reserve would be removed from public open space.
 - 3.4.2 Disadvantages The degree to which native plant production could be increased would be less, with fewer plants available for Council and community projects. Employment opportunities for disadvantaged members of the community may be fewer.

4. Detail / Te Whakamahuki

- 4.1 The Green Effect Trust is a charitable trust board registered as a charity on the Charities Register. Incorporated in 1987, the Trust has a longstanding relationship working alongside the Council and the local community.
- 4.2 The Trust have operated a native tree nursery (Trees for Canterbury) since 2005 from a leased area on the Council-owned Charlesworth Reserve at 54 Charlesworth Street. They were formerly located on Opawa Road but were required to move for motorway improvements.



4.3 The Trust objectives include:

Employment: in addition to employing core staff, the Trust provides a sense of involvement in the community for disadvantaged people (physically, intellectually, socially and long term

unemployed) by providing opportunities to work in an environment of acceptance and support for training and self development, installing self esteem and good work habits.

Education: working with educational institutions providing assistance in teaching of environmental awareness.

Re-generation: cultivating eco-sourced plants for community plantings, school planting programmes and Council restoration projects. Members of the Trust are actively involved on a voluntary basis with plantings alongside Council park rangers, the Avon Heathcote Ihutai Trust, Brookhaven Residents Association and other volunteers from throughout the Christchurch area.

- 4.4 The Trust grows in excess of 150,000 of plants per year of which around 40,000 are donated for community purposes, generally community plantings. The remainder are sold on a commercial basis. As a Charitable Trust all profits are re-invested in the organisation.
- 4.5 The current lease for a ten year term was renewed in 2021 under the terms of the lease for a further four years with final expiry in 2024. Given the nature of the activity and the viability of the operation it is likely that a new lease will be entered into for a further term under existing Council policy.
- 4.6 The current lease area is 14,959 square metres. The Trust have applied to extend the lease area by a further 2978 square metres to enable expansion of the nursery growing capacity. This is in response to the community need for increased supply of native plants to assist in development of the red zone and to meet Government aspirations for the planting of one billion trees.
- 4.7 The proposal involves an extended lease area of 2978 square metres as shown in AttachmentA. The key impacts arising from the proposal are:
 - Reduction of open space by approximately 30%. Note that the remaining open space in the immediate area remains significant at around 7,000 square metres. The proposal complements the scenic/planted nature of the reserve as a whole. The reduction of open space is acceptable given the remaining open space area.
 - Re-alignment of the existing walkways. An extended lease area would affect the existing informal track adjacent to the current plantings. This has been reviewed by Regional Parks who have advised that they are happy with the proposal. There is a cycleway upgrade planned for late 2021-early 2022 as shown on attachment C. It is intended to wait and see how use of this new track develops before making a decision on whether to form an additional walking track. The Trust have indicated a willingness to contribute to the cost of the track.
 - Existing plantings on the lease boundary screening the existing nursery are to be incorporated into new lease area with minimum removal. The proposed new lease boundary will be replanted by the Trust with new screening which will minimise the impact of the fencing over time. Refer attachment B for proposed layout of nursery.
 - Construction of two new buildings, a shade house (24m by 18m) and a crop cover structure (15m by 6m) is also proposed but these are within the current lease area and well screened from the public space. The new area is to be used for maturing young plants, does not include additional buildings and in some respects will provide an increased area of vegetation. The new area will require new perimeter fencing to be installed. In this regard it would be easily reversed and converted to public use should it no longer be required for nursery use. The proposal has received preliminary support for 'one billion trees funding' contingent on receiving secure tenure and this will fund the proposal together with existing cash reserves.



- 4.8 The use of the land will be subject to the lessee meeting all regulatory requirements including any matters relating to activity in proximity to overhead power-lines. Preliminary enquiries by the lessee indicate that compliance is achievable.
- 4.9 The rental for the Trust was determined by the Community Board in 2014 on the basis of a non-commercial rent taking in to account the charitable nature and the community benefit provided by Trust. The rent was increased in 2021 on the basis of CPI. It is proposed to pro rata the current rent for the additional area.

Community views and preferences

- 4.10 A notice advertising the proposed lease variation was published in the public notices section of The Press newspaper on 27 March 2021, and three information signs were placed in the reserve close to the Charlesworth Street and Waterman Place entrances.
- 4.11 An engagement leaflet, inviting feedback, was distributed on 26 March 2021 to approximately 50 households in the immediate vicinity of the nursery site on Charlesworth Street, along with 6 identified key stakeholders including Mahaanui Kurataiao Limited.
- 4.12 Feedback on the proposal was received from three respondents, one in support, one in opposition, and one identifying issues that they believe can be resolved. A fourth individual emailed staff to ask questions about the nature and tenure of the occupation, but did not subsequently provide written feedback.
- 4.13 The Avon-Heathcote Ihutai Trust have indicated their support for the proposal, viewing the extension as a positive move, with the nursery being able to provide more tree seedlings to the community.
- 4.14 The second respondent, who is a long-time local resident and walks their dog in Charlesworth Reserve every day, has registered their total opposition to the proposal, explaining that:
 - 4.14.1 The reserve is a hidden gem with many local residents, themselves included, getting much pleasure out of the open space on their doorstep.
 - 4.14.2 It is bad enough that the cycle track is going through the reserve, but the thought of a commercial operation encroaching into this space is appalling.
 - 4.14.3 Apart from the loss of the park land, it is setting a terrible precedent for future development applications from other businesses, i.e. Mitre 10.
- 4.15 Staff acknowledge the concerns raised by the second respondent and would respond as follows:
 - 4.15.1 It is the view of staff that the reduction in open space of approximately 30% is acceptable given that the remaining open space area is around 7,000 square metres.
 - 4.15.2 Under the Christchurch City Council Dog Control Policy 2016, dogs are only allowed in Charlesworth Reserve on the grass area with no wildlife values, and must be leashed. Dogs are prohibited in the wildlife habitat and regenerating bush areas. Staff are of the view that there will still be sufficient open grassed space for walking a leashed dog. Early development plans for the reserve also indicate that a cycleway was proposed to cross the reserve as early as 2001.
 - 4.15.3 The Green Effect Trust is operating the Trees for Canterbury production nursery on Charlesworth Reserve on a charitable basis essentially for the benefit of the community, and funds raised by the sale of native plants are re-invested in the organisation. On this basis, the proposed variation to the lease is not considered by Council to be an expansion of a commercial operation.

- 4.15.4 Staff are also of the view that this expansion would not be setting a precedent for expansion of other adjoining strictly commercial businesses into the reserve, given the high ecological values of the reserve and its wetlands, and the provisions in the Christchurch District Plan regulating activities in this location. It is noted however that there is a parcel of land approximately 5 metres wide along the southern boundary of Charlesworth Reserve which has been planted in native vegetation, thus appearing to be part of the reserve, but is in fact under private ownership.
- 4.16 The third respondent, Orion NZ Ltd, is the owner of existing 66kV electricity distribution lines, and associated support structures, that cross Charlesworth Reserve. While there have been ongoing discussions with Orion NZ Ltd over the previous months, formal feedback has been received stating concerns that, without appropriate safeguards, the expansion of the nursery enabled by the proposed lease would compromise the safe operation, maintenance, repair, and upgrade of the electricity network. These concerns relate to the earthing of the new conductive metal perimeter fencing and its construction methodology, and the height of new vegetation both in the nursery and planted in ground.
- 4.17 Orion NZ Ltd have stated that subject to a number of conditions being met, and these have been specified in their submission, they do not object to the application. Orion NZ Ltd staff are confident that their concerns can be worked through and will provide further information to the applicant as required.
- 4.18 Further Requests to Expand Leased Area The Council and Community Board can only put controls on land use through an approved management plan that has been publically consulted. If the Trust wishes to make further requests to utilise more land the process wold be subject to consultation and appropriate approvals.
- 4.19 The decision affects the following wards/Community Board areas:

5.7 The activities proposed for the area will meet current codes for accessibility.

6. Resource Implications / Ngā Hīraunga Rauemi

- 6.1 Cost to Implement preparation of lease variation document to be recovered from the lessee; Staff costs of processing the application are covered by Parks Unit operational budgets.
- 6.2 Maintenance/Ongoing costs All costs are the responsibility of the lessee.
- 6.3 Cost to re-route pathways to be determined; Costs of two new connecting pathways are to be met by the Major Cycleways–Rapanui–Shag Rock Project. If the need for an additional path is identified as a result of changed use over time, the Trust is to contribute by negotiation. Current maximum cost would be \$4000 for 100 metre path length at \$40 per metre.
- 6.4 Funding Source All costs are the responsibility of the lessee other than staff time to be covered by Parks Unit operational budgets.








Attachment B-Proposed Layout of Nursery Extension

1. Purpose of the Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is for the Linwood-Central-Heathcote Community Board to recommend to the Council, as landowner, to approve the landscape improvements to the Victoria Street Green Triangles. This report has been written as a request from the adjoining landowner to staff.
- 1.2 The decision in this report is of low significance in relation to the Christchurch City Council's Significance and Engagement Policy. The level of significance was determined by completing the Significance and Engagement matrix.
- 1.3 A small area of the Victoria Street Green Triangle reserve is leased to the Black and White Café Cartel. Next to their leased area of the reserve is an area covered with astro-turf that was placed over the ground as part of the Gap Filler programme after the 2010/11 earthquakes.
- 1.4 The astro-turf is reaching the end of its usable life and needs replacing. The adjoining commercial building owner, in conjunction with the Black & White Café lessee, have offered to replace the astro-turf with grass and to extend the paving from the public footpath to their leased area at no cost to Council.

2. Officer Recommendations / Ngā Tūtohu

That the Waikura/Linwood-Central-Heathcote Community Board recommend to the Council to:

- 1. Approve the landscape improvements to Victoria Street Green Triangle at 81 Victoria Street as shown in section 3.4 of this report
- 2. Accept the offer from EPOCH CHCH Limited (83 Victoria Street) to construct and fund the total development of the landscape improvements for Victoria Street Green Triangle (81 Victoria Street) as shown in this report at no cost to the Council.

3. Reason for Report Recommendations / Ngā Take mō te Whakatau

- 3.1 After the 2010/11 earthquakes the building next to the Victoria Street Green Triangle was demolished. The damaged turf on the end of the reserve was covered over with astro-turf as part of the Gap Filler programme. The astro-turf is coming to the end of its life and will need replacing. There is no funding allocated in the LTP for the replacement or development of this area.
- 3.2 An area of the reserve is leased to the Black and White Café who use it for outdoor seating. The Café lessee and owner of the adjacent building have engaged a landscape architect who has proposed to replace the astro-turf with grass for the area within the reserve. For the public space between the leased area and the footpath along Victoria Street the designer has proposed 3 wooden seats and paving that matches the public footpath.

- 3.3 A small shrub garden with a tree and two public seats has been proposed to provide shade and additional seating to the public. Native plants have been selected for the landscaped area. The new garden and seats are available to the public and not included in the leased area of the café.
- 3.4 The owners of the adjacent building have offered to develop and fully fund the landscape improvements and there are no funding requirements to Council (refer Attachment A).



3.5 **Proposed landscape design for the Victoria Street Green Triangle**

4. Alternative Options Considered / Ētahi atu Kōwhiringa

4.1 The alternative option is to leave the area as it is – this is not recommended. The astro-turf is coming to the end of its life and there are no funds to either renew or reinstate the area to grass and paving.

- 5.1 The landscape proposal is supported by the two adjoining commercial businesses: the Black and White Café and Mr Sushi. The community have not been consulted.
- 5.2 The Matapopore Charitable Trust are supportive of the landscape improvements.

1. Purpose of the Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is to consider the removal of additional trees within Lancaster Park. This report has been written owing to a conflict with the trees and the final soil level heights for the project.
- 1.2 The decision in this report is of low significance in relation to the Christchurch City Council's Significance and Engagement Policy. The level of significance was determined as low due to the trees being of small stature and a common species.

2. Officer Recommendations / Ngā Tūtohu

That the Waikura/Linwood-Central-Heathcote Community Board:

1. Approves the removal of three Common Lime trees remaining within the south east corner of Lancaster Park.

3. Reason for Report Recommendations / Ngā Take mō te Whakatau

- 3.1 In total six trees are shown within the spatial plan to be retained within the south east corner. All of these trees are of small stature (less than 6m) and are *Tilia x europaea* (Common Lime) which is a common species of tree. In total they contribute a canopy cover of approximately 56m^{2...}
- 3.2 During the earthworks that are currently underway within Lancaster Park it has become apparent that the intended retention of the trees located within the South East corner are situated above the finished surface levels. Due to the nature of the earthworks, three of the six trees have already been removed.
- 3.3 The position of the remaining trees in relation to the proposed finished height will result in the trees sitting above the surrounding ground level on mounds which would not be aesthetically pleasing.
- 3.4 Owing to the trees being of small size and the species being readily available it would be simple and cost effective to remove the trees and replant once the works have been completed. This will also provide council with the ability to change the tree species if it decides another would be better suited.
- 3.5 As part of the development of Lancaster Park a tree planting plan will be developed which will include a minimum of two trees planted for every tree removed in order to comply with the



Council Tree Policy. This will also require the canopy cover lost through tree removals during the project to be replaced within 20 years. Based on this the removal of the trees will be mitigated.



Images above show two of the trees which remain on-site and are proposed for removal.

4. Alternative Options Considered / Etahi atu Kowhiringa

- 4.1 Adjusting the earthworks plans to retain the trees has been considered, however, given the relatively low value of these trees, it would be more cost effective to remove the trees and replant once the works have been completed.
- 4.2 Transplanting the trees for the duration of the project and replanting as part of the final landscaping has been considered, however, the cost to transplant the trees to another site until the works are completed and then to transplant them back outweighs the value of the trees.

- 5.1 In general, the community would like to see more trees planted in the most appropriate sites. This will be achieved through the tree planting plan.



3.2.2 Single Fin Mingle 2021



Opening with a ceremony and mihi Whakatau, followed by a movie night gala at Sumner's Hollywood Theatre, the four day long festival featured live music, soiree, board demo, art exhibition and live jazz music and much more.

Despite some wild weather and huge surf conditions for the third day, the surf contest itself saw a range of participants spanning all ages and attracted over a thousand spectators who lined the Esplanade to watch New Zealand's top long-boarders.

A first for the event; an impromptu competition saw several keen twin fins and mid length boarders paddled out after morning competition heats for a go, an occasion now aptly known as the Mingle Mash-up. After the competition the village car park was turned into a makeshift venue for the *Sumner Village knees-up* with performances from local artists and bands. The weekend concluded with prize giving on the Sunday evening at the Sumner Surf Life Saving Club.

1. INTRODUCTION

The Linwood-Central-Heathcote Community Board (the Board) thanks the Council for the opportunity to submit on the Te Mahere Rautaki Kaurera Our Draft Long Term Plan 2021-31.

The Board would like to speak to this submission at the hearings to be held in May 2021. The Board has the following comments to make for the Council's consideration on the information contained in the Consultation Document, the Draft Long Term Plan 2018/2028.

2. SUBMISSION

2.1. **Rates:** What do you think of this plan for an average residential rates increase of 5 per cent for 2021/22 and an overall rates increase of 4 per cent over the next 10 years?


The Board understand the rates increase however do not support the increases. The increases take more money from ratepayers, many of whom have not had a pay rise in the last few years. The proposed rates increase are out of kilter with the reality for many of the Board's area citizens.

The Board wishes the uniform general charge decrease from the current level to nil.

2.2. Investing in Upgrading and protecting our city's water networks: We are proposing to invest 41 per cent (\$2.329 billion) of our capital spend on water infrastructure. Have we got the balance right? If not, what changes would you like to see?

The Board are opposed to volumetric water charging as the charging will be an added burden on the community board areas communities and in particular already marginalised communities. There is no evidence that increased volume of water use is equivalent to wastage of water, much of which is used for gardening purposes. Further to this, it is inherently unfair to charge citizens for water when to Environment Canterbury continues to issue large water extraction consents for free.

- 2.3. **Potential Disposal of Surplus Council-owned properties:** *Help us decide their future what do you think of this proposal to dispose of surplus properties?* The Board agreed with the disposal of surplus Council-owned properties in consultation with the community in which the surplus property is located.
- 2.4. **Community Funding** The Board supports funding staying at current levels and with the current funding model.
- 2.5. **Cycleway Local Connections Programme:** The Board support the cycleway local connections programme. The Board has recently supported a community proposal to have a cycleway connections on Stanmore Road- from both Worcester St (Heathcote Express) to Linwood Village and then from the village to the red zone cycle way on the Ōtākaro Avon.

- b. Opawaho Lower Heathcote Working Party.
- c. Bromley Area Traffic Concerns.
- 2.7. Sumner Village Green: The funding for the Sumner Masterplan has been deferred however, the Board wishes that a small amount of the funding (approximately \$300,000) be transferred from one of the masterplan projects (Burgess Street viewing platform) to enable the Sumner Village green to be done at the same times as the Bays Area skatepark.
- 2.8. Levels of Service: The Board wishes to see the current levels of service that staff provide to the Community Boards be retained, and then similarly for the impending Representative Review outcome.

1. INTRODUCTION

The Linwood-Central-Heathcote Community Board (the Board) thanks the Council for the opportunity to submit on the Draft Development Contributions Policy 2021.

The Board would like to speak to this submission.

2. SUBMISSION

- 2.1. The Waikura/Linwood-Central-Heathcote Community Board area has and is experiencing the impact of increased high to medium density housing developments replacing many quarter acre/one house lots in historic established suburbs.
- 2.2. The Board has heard from its community, grieving for the loss of amenity in the areas that high density developments have been established. The Board project "Greening the East" looked at ways of addressing the deficit of tree canopy, and greenspace within the Inner City East. This additional work may have assisted if development contributions could be spent in the specific street or neighbourhood in which the development had taken place.
- 2.3. The Board is also aware of the pressure on Council infrastructure in older established suburbs, owing to demand on infrastructure having to service significantly greater numbers of residences than was originally intended.
- 2.4. The Board support a Central City Development Contribution. The introduction of a Central City Development Contribution would assist the impact of increased high to medium density housing developments replacing many quarter acre/one house lots in historic central city established suburbs.

Board Request

That any Development Contributions received by Council for a high to medium density residential development within an established suburb is used to upgrade the local amenity and to upgrade the Council's infrastructure in the same street or neighbourhood to accommodate the increased demand on aging infrastructure and not to use in other areas of the city.

1. INTRODUCTION

The Linwood-Central-Heathcote Community Board (the Board) thanks the Council for the opportunity to submit on the Draft Ōtautahi Christchurch Climate Change Strategy 2021.

The Board would like to speak to this submission at the hearings to be held in May 2021.

2. SUBMISSION

- 2.1. As a significant city leader the Board believes that Council needs to role model behaviour that mitigates the effects of Climate Change on Christchurch city, most importantly focussing on prevention.
- 2.2. The Board has noted with approval that staff reports now have a section on *Climate Change Impact Considerations*, which demonstrates the importance Council places on the matter.
- 2.3. The Linwood ward within the Community Board area is the ward that is most highly impacted by climate change through coastal inundation, rising ground water and flood plains.
- 2.4. Climate change interacts with many other environmental and social aspects and factors affecting human and natural systems. Climate change impacts and adaptation options cannot be considered separately. It rather requires an interactive approach, applying trans-disciplinary communication.
- 2.5. The strategy will need strong buy in from the community through creating awareness and education. The Board thinks this should be communicated regularly through the Council's communications to the community in simple language for all cultures.
- 2.6. The Board considers that water conservation, reuse of water, and rainwater harvesting is an important part of mitigation of climate change and thinks that this area should be enlarged in the strategy.
