8. Wigram Area - Proposed Speed Limit Review Board Consideration

Staff in attendance spoke to the agenda report and the consultation process that was undertaken.

7. Creyke Road, Ilam - Proposed P120 Restrictions

1. Purpose of the Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is for the Waipuna Halswell-Hornby-Riccarton Community Board to consider the approval of 120 minute parking restrictions on a part of Creyke Road in Ilam.
- 1.2 This report has been written in response to requests from local residents to investigate the effect of long term parking upon the availability of short term parking for local residents, their visitors and students.
- 1.3 The decisions in this report are of low significance in relation to the Christchurch City Council's Significance and Engagement Policy. The level of significance was determined by the low level of impact and low number of people affected by the recommended decision.
- 1.4 The community engagement and consultation outlined in this report reflect the assessment.
- 1.5 The recommended option is to install the 120 minute parking restrictions on Creyke Road in accordance with **Attachment A**. A location plan is shown in **Attachment B**.
- 1.6 These measures have been requested to:
 - Increase opportunities for short stay parking for visitors, customers and couriers.
 - Increase turnover of parking spaces throughout the day.
 - Deter all day parking by students and staff.

2. Officer Recommendations / Ngā Tūtohu

That the Waipuna Halswell-Hornby-Riccarton Community Board:

- 1. Approves that a parking place on the south side of Creyke Road commencing at a point 109 metres south east of its intersection with Montana Avenue and extending in a south easterly direction for a distance of 13 metres be restricted to a maximum period of 120 minutes between the hours of 8am and 6pm Monday to Sunday except during public holidays.
- 2. Approves that a parking place on the south side of Creyke Road commencing at a point 136 metres south east of its intersection with Montana Avenue and extending in a south easterly direction for a distance of 39 metres be restricted to a maximum period of 120 minutes between the hours of 8am and 6pm Monday to Sunday except during public holidays.
- 3. Revokes any previous resolutions pertaining to traffic controls made pursuant to any bylaw to the extent that they are in conflict with the traffic controls described in resolutions 1 and 2 above.
- 4. Approves that these resolutions take effect when the road markings that evidence the restrictions described in the staff report are in place (or removed in the case of revocations).



3. Reason for Report Recommendations / Ngā Take mō te Whakatau

- 3.1 Two residents on Creyke Road have requested a review of the restrictions at the two existing bays to meet the needs of the wider community.
- 3.2 The recommendations will improve short stay parking for local visitors and students attending University for relatively short periods.

4. Alternative Options Considered / Ētahi atu Kōwhiringa

Maintain the status quo

- 4.1 The advantages of this option include:
 - 4.1.1 Provides more convenient long term parking opportunities for staff and students.
- 4.2 The disadvantages of the option include:
 - 4.2.1 Does not address the residents' concerns over the lack of short stay parking opportunities during the weekdays.

5. Detail / Te Whakamahuki

- 5.1 Local residents contacted Council staff concerning the appropriate use of the two existing parking bays on Creyke Road near the Engineering Campus. One bay is currently subject to a 5 minutes restriction (P5) and the other is unrestricted.
- 5.2 Staff monitored the usage of these spaces during the week and it was evident that the spaces were used intensively. It was apparent that P5 restrictions appeared to be an unusual restriction at this location, since there were no shops or businesses nearby that might be associated with very short drop off pick up restrictions.
- 5.3 Similarly, the unrestricted bay was not consistent with other bays on Creyke Road which are all subject to short stay restrictions.
- 5.4 Consequently a proposal for short stay parking was drafted and issued for consultation purposes.
- 5.5 Approval is required by the Waipuna Halswell-Hornby-Riccarton Community Board.
- 5.6 If approved, the recommendations will be implemented within the next financial year.

Community Views and Preferences

- 5.7 Staff initially prepared a draft proposal for providing P30 restrictions for both parking bays.
- 5.8 Affected property owners and residents on Creyke Road, the University of Canterbury and the Ilam and Upper Riccarton Residents Association were contacted by letter and invited to comment.
- 5.9 Three submissions were received from property owners and tenants, of whom two supported P120 restrictions instead of P30 and one supported the P30 proposal.
- 5.10 Staff evaluated these submissions and noted that other parking bays along Creyke Road and Montana Avenue are also subject to P120 restrictions. Consequently the proposal was amended to P120 8am to 6pm Monday to Sunday. Staff contacted the University of Canterbury again and they had no objections to a P120 proposal.
- 5.11 Staff consider that a P120 proposal is preferred by the submitters and that the proposal is consistent with the Council's suburban parking policy to discourage all day parking on street in busy urban areas. Consequently staff are recommending the proposal in this report.
- 5.12 The Team Leader Parking Compliance supports the preferred option.



5.13 The do nothing option is inconsistent with the community request for additional short stay parking opportunities.

6. Policy Framework Implications / Ngā Hīraunga ā- Kaupapa here

Strategic Alignment / Te Rautaki Tīaroaro

- 6.1 Council's strategic priorities have been considered in formulating the recommendations in this report, however this area of work is not specifically covered by an identified priority.
- 6.2 The recommendations in this report are also consistent with the anticipated outcomes of the Traffic Safety & Efficiency Service Plan in the <u>Councils Long Term Plan (2018 2028)</u>.

Policy Consistency / Te Whai Kaupapa here

- 6.3 The recommendations in this report are consistent with the <u>Christchurch Suburban Parking</u> <u>Policy</u>.
- 6.4 Policy 1 relates to prioritising suburban road space according to Table 1 Road priority matrix. Within the matrix for residential areas, the seventh priority is to provide short stay parking.
- 6.5 On-street parking for commuters is classified as the eighth (lowest) priority in residential areas.

Impact on Mana Whenua / Ngā Whai Take Mana Whenua

6.6 The effects of this proposal upon Mana Whenua are expected to be insignificant.

Climate Change Impact Considerations / Ngā Whai Whakaaro mā te Āhuarangi

6.7 This proposal does not have any significant effect upon carbon emissions and Climate Change.

Accessibility Considerations / Ngā Whai Whakaaro mā te Hunga Hauā

6.8 The effects of this proposal upon accessibility are expected to be insignificant.

7. Resource Implications / Ngā Hīraunga Rauemi

Capex/Opex / Ngā Utu Whakahaere

- 7.1 Cost to Implement approximately \$300 for the new signs and line markings and \$750 for producing the report.
- 7.2 Maintenance/Ongoing costs approximately \$300/year.
- 7.3 Funding Source Traffic Operations Signs and Markings budget (installation)/existing Transport maintenance budgets for ongoing maintenance.

- 8.2 The Community Boards have delegated authority from the Council to exercise the delegations as set out in the Register of Delegations. The list of delegations for the Community Boards includes the resolution of stopping restrictions and traffic control devices.
- 8.3 The installation of any signs and/or markings associated with traffic control devices must comply with the Land Transport Rule: Traffic Control Devices 2004.

- 8.4 There is a legal context, issue or implication relevant to this decision.



3.3 Participation in and Contribution to Decision Making

- 3.3.1 Report back on other Activities contributing to Community Board Plan [for items not included in the above table but are included in Community Board Plan]
 - Christchurch Regeneration Acceleration Facility Roading and Transport Improvements (CRAF) Fund Projects

A Joint Briefing of the Board and the Fendalton-Waimairi -Harewood Community Board was held on 11 May where transport staff presented about the CRAF funding of 6 Million dollars available for accessibility, safety and asset condition projects in the Waipuna Halswell-Hornby-Riccarton Community Board and Waimāero Fendalton-Waimairi-Harewood Community Board areas.

Staff sought direction from Board members on appropriate projects to be undertaken with the funds available. A range of individual projects were discussed, noting Board priorities.

Staff will prepare options for a programme based on the direction provided by members and present these for consideration at an upcoming briefing. Formal reports will be provided to the Boards for those projects that are recommended to be undertaken as part of the programme.

3.3.2 Council Engagement and Consultation.

Proposed replacement Freedom Camping Bylaw 2021

Open for feedback: 17th May 2021 - 21st June 2021

Changes are proposed to make some improvements to the Freedom Camping Bylaw that aims to balance freedom camping opportunities with necessary limitations to ensure areas are protected.

• Plan Change 7 Managing Significant Indigenous Vegetation

Open for feedback: 19th May 2021 - 21st June 2021

Plan Change 7 seeks to better protect and maintain indigenous vegetation while still providing for its clearance, where it is small scale and low impact, to provide for the continuation of farming activities. It will also amend the policies and rules around the type and size of native trees and plants (indigenous vegetation) that can be cleared generally across the district, and within areas of existing pasture (otherwise known as improved pasture) on coastal farmland.

• Representation Review

The Board's Submissions Committee resolved at its meeting on 10 May 2021 to adopt the attached submission (Attachment B) as the Board submission to the Christchurch City Council on its initial proposal on the Representation Review.

The submission was lodged on 11 May prior to the closing date for submissions on 16 May 2021. The Board Chairperson, Deputy Chairperson, and Chairperson of the Board's Submissions Committee spoke to the submission at the hearing held on 24 May 2021.



3.4 Governance Advice

3.4.1 **Parking on Brigham Drive**

At its meeting on 2 March 2021 the Board discussed on-going concerns regarding parking on Brigham Drive where residents report vehicles parking over driveways and agreed to request staff to investigate and provide advice on parking issues on Brigham Drive, particularly vehicles parking over driveways.

Staff have advised that the issue has been addressed by the installation of new parking ticks.

4. Advice Provided to the Community Board

4.1 Oakhampton Reserve play equipment renewal

At the Board meeting on 4 May 2021 the Board noted the condition of the play equipment at Oakhampton Reserve and agreed to request that staff advise on whether a play equipment renewal in Oakhampton Reserve is planned. Staff have now advised that project ID 61777 in the draft Long Term Plan is Community Parks Play Space Renewals and this project includes funding for the renewal of Oakhampton Reserve as follows" play equipment renewal:

Financial Year 2023 \$15,000

Financial Year 2024 \$90,000

If approved for inclusion in the Long Term Plan a separate project will be set up for Oakhampton Reserve Play Space Renewal.

4.2 **Roydon Quarry Appeal**

At its meeting on 1 December 2020 the Board discussed the Templeton Residents Association involvement in the Roydon Quarry Appeal process and agreed to request that staff engaged in the Roydon Quarry appeal on behalf of the Council investigate options to assist the Templeton Residents Association with its appeal.

The attached memorandum (Attachment C) has now been provided in response to this request and to provide an update on the progress of the appeal. The memorandum advises that all parties to the appeals against the Roydon Quarry indicated to the Court that they are willing to take part in mediation with mediation set down for 17-31 May. Mediation topics are:

- Traffic issues
- Dust issues
- Noise and vibration other than traffic
- Water quality and cleanfill, lawfulness of conditions, consequential changes

Not all parties are involved in all topics.

The Council has joined as a party to the Fulton Hogan appeal in relation to the appeal point concerning condition 40 that addresses heavy vehicle movements leaving or accessing the Roydon Quarry. The Templeton Residents Association has joined as a party to the Fulton Hogan appeal opposing all of the changes to conditions sought by Fulton Hogan.

The Council's involvement in the appeal is limited in scope while the scope of relief sought by the Templeton Residents Association is wider.




Legal Staff advise that as the Council is not seeking the same result as the Templeton Residents Association there is no assistance that the Council can or should provide to the Association in these appeals and the Council and Templeton Residents Association should pursue their objectives separately.







1. INTRODUCTION

- 1.1. The Waipuna/Halswell-Hornby-Riccarton Community Board ("the Board") appreciates the opportunity to make a submission on the Council's Representation Review Initial Proposal 2021 ("the Proposal").
- 1.2. This submission was compiled by the Board's Submissions Committee under the delegated authority granted by the Board.
- 1.3. Throughout the submission, reference is made to Statistics New Zealand Statistical Area 2 Unit ("SA2") boundaries wherever possible as a measure of defining boundaries, as these have already been clearly defined.
- 1.4. Population figures referred to in the submission have been estimated according to Statistics New Zealand2018 Census figures – www.stats.govt.nz
- 1.5. The Board wishes to be heard in support of its submission.

2. SUBMISSION

- 2.1. The Board supports the retention of the first past the post electoral system and the proposal for the Council to be made up of 16 councillors, elected one elected from each ward, plus the mayor elected at large. The Board agrees that this will provide effective representation for the citizens of Christchurch.
- 2.2. The Board supports the proposal to retain the existing 16 wards that reflect current communities of interest and meet fair representation requirements (+/- 10 per cent).



2.3. The Board recognises that some adjustment to the existing ward boundaries will be required to account for growth in some parts of the city and ensure that each elected member represents roughly the same number of people. The Board emphasises, however, the need for both wards and community boards to be based on distinct and recognisable current communities of interest as well as meeting fair representation requirements. In terms of the specific changes proposed the Board comments as follows:

2.3.1 Halswell Ward:

The Initial Proposal is for the areas covered within the Statistics New Zealand Awatea South and Broken Run Statistical Area 2 (SA2) Unit boundaries to be included in the proposed Hornby Ward. The Board considers that residents in this area do not see themselves as part of Hornby and rather identify with Halswell, having common interests with that area. In recognition of this the Board seeks the removal of the area within Awatea South and Broken Run SA2 Unit boundaries from the proposed Hornby Ward and inclusion into the proposed Halswell ward by altering the ward boundary in this vicinity from the line of the Christchurch Southern Motorway to the SA2 unit boundaries as indicated on the attached plan (Attachment A). The Board notes that this is likely to result in an increase in the Halswell population by approximately 1617 people (Broken Run 576 and Awatea South 1041).

In addition the Board does not support the proposal for the residential area on both sides of Kennedys Bush Road and adjoining streets, namely the area covered within the Statistics New Zealand Kennedys Bush SA2 Unit boundaries, to be included in the proposed Cashmere Ward. The Board considers that this area has a significantly greater affiliation with the Halswell area, noting that many of the properties are in close proximity to the Halswell Quarry. The Board therefore asks that the ward boundary be redrawn so that this area is in the Halswell Ward. This change is likely to result in an increase of approximately 217 people only in the Halswell population.

2.3.2 Hornby Ward

Removal of the areas covered within the Awatea South and Broken Run SA2 Unit boundaries from the proposed Hornby Ward and inclusion into the Halswell ward as advocated at 2.3.1.above is likely to result in a decrease in the population of the proposed Hornby ward of approximately 1617 people. The Board opposes the proposal to include the Broomfield area, currently in the Hornby Ward, in the proposed Harewood Ward. There is a very strong affinity



between the Broomfield and Hei Hei and Hornby areas while the Board considers Broomfield residents have little commonality with Harewood residents. Removal of this area from the Hornby ward would result in the division of a current community of interest that has been rated as one of the most deprived areas of the city in the Social Deprivation Index. The Board therefore urges an adjustment of the proposed ward boundary to remove the areas within the Statistics New Zealand Broomfield SA2 Unit boundaries from the Harewood Ward and incorporate them into the Hornby Ward. (See map Attachment B). This change is likely to result in an increase in the population of the proposed Hornby ward of approximately 2571 people.

The Board also advocates for the inclusion into the Hornby Ward of that part of the area within the Statistics New Zealand Yaldhurst SA2Unit boundary, that extends from the boundary with the Broomfield SA2 Unit along Buchanans Road through to Pound Road and to Yaldhurst Road as shown on the plan attached (see Attachment B) that is currently proposed to be in the Harewood Ward. The Board considers that this area has an affinity to the Hornby area but does not relate to Harewood.

With the maintenance of communities of interest in mind, the Board further seeks alteration of the proposed boundary between the Riccarton and Hornby Wards to shift the area within the Statistics New Zealand Riccarton Racecourse SA2 Unit along with a portion of Hornby Central SA2 unit from the Riccarton Ward into the Hornby Ward. See plan attached (Attachment B). This change will mean that the entire Hornby Central and Riccarton Racecourse SA2 Units will be in the Hornby Ward with an approximate population increase of 1206 people.

2.3.3 Riccarton Ward

Removing the area within the Statistics New Zealand Riccarton Racecourse SA2 Unit and the portion of Hornby Central SA2 unit from the Riccarton Ward into the Hornby Ward as requested above at 3.2.2 the area covered from the Riccarton Racecourse SA2 Unit boundary from the proposed Riccarton Ward into the Hornby Ward will decrease the population of the proposed Riccarton Ward by approximately 1206 people.

The Board strongly opposes the proposed separation of the University of Canterbury with one campus proposed to be in the Waimairi ward the other proposed to be



within the Riccarton Ward. Cleary the areas surrounding both campuses share a community of interest. The Board therefore seeks to have those areas within the Statistics New Zealand Ilam University and Bush Inn SA2 Units that are proposed for the Waimairi ward included instead in the Riccarton Ward so that the entire Ilam University and Bush Inn SA2 Units will be within the Riccarton Ward with a resulting increase of approximately 1721 (Ilam University unit 321 and Bush Inn Unit 1400) in the population of Riccarton.

Of particular concern to the Board is the triangular area Peers Street, Riccarton Road, Waimairi Road that it considers must be retained in Riccarton to maintain a community of interest avoid separation of the two Bush Inn Shopping centres.

The Board supports the inclusion of all of Mona Vale Park and Garden into one Community Board area and agrees that it has more affinity with the Fendalton Ward. In addition the Board considers that the small triangle area to the north of Kotare Street, that is currently in the Riccarton Ward and stays in Riccarton under the initial proposal, would be better aligned within the Fendalton Ward. This includes properties from 56 Kotare Street through to Clyde Road, the southern (odd numbered) side of Medbury Terrace and Clyde Road between Kotare Street and Medbury Terrace.

The Board notes that it is unclear in the proposal whether the Matai Street section of the Boundary of the Riccarton Ward runs down the middle of the street or the whole street is included. The Board suggests that it is more appropriate that both sides of Matai Street should be included in the Riccarton ward as the residents group Riccarton House/Kilmarnock Residents Association covers both sides of Matai Street. The current Riccarton boundary is the river so the ward includes the whole of Matai Street and this could continue as the boundary if required.

2.4. The Board supports the proposal to reduce the number of urban community boards from six to five, by the disestablishment of the existing Linwood-Central-Heathcote Community Board and the inclusion of the Linwood, Central, and Heathcote wards in other community Board areas. This change will provide five urban Boards each representing three wards with six elected members, two from each ward and three appointed councillors, one from each ward, making a total of nine members. The Board considers that this is preferable to the current situation of six urban Boards, three representing three wards and three representing two wards. It provides a more equitable arrangement of evenly sized Board areas with an



even distribution of resources and workload and equal ability to fairly represent their communities.

- 2.5. The Board accepts that the isolated nature of the Banks Peninsula Ward and its distinct communities with common interests and issues warrant separate representation by one Councillor and the retention of the Banks Peninsula Community Board with seven elected members and the councillor elected from the Banks Peninsula ward appointed to the Board, making a total of eight members.
- 2.6 The Board supports the formalisation of the current use of te reo Māori community board names in conjunction with the ward names of the community board areas. This recognises our bi-cultural relationship and formalises the use of the names.

3. CONCLUSION

3.1. The Board requests that the council considers the matters set out above in relation to the Representation Review Initial Proposal 2021.



Roydon Quarry Appeals – update - and options for staff assistance for the Templeton Residents Association appeal lex20481

Purpose of memo

- 1. To provide an update for the Community Board on the progress of the appeals.
- 2. To respond to the Community Board resolution of 1 December 2020 that

"The Board agree to request that staff engaged in the Roydon Quarry appeal on behalf of the Council investigate options to assist the Templeton Residents Association with its appeal"

Progress report

- 3. All parties to the appeals against the Rydon Quarry have indicated to the Court that they are willing to take part in mediation.
- 4. Prior to setting dates for mediation the Court required the parties particularly those without lawyers acting for them to be more specific about the issues that concerned them and the facts agreed and not agreed.
- 5. The Court has now directed that the parties enter mediation. The mediation dates are from 17-31 May.
- 6. The Court and parties have structured the mediation to address appeal topics sequentially. Not all parties are involved in all topics (we comment on this further below). The topics are:

Topic 1: Traffic issues (17-19 May) Topic 2: Dust issues Topic 3: Noise and vibration other than traffic

Topics 4-6: Water quality and cleanfill, lawfulness of conditions, consequential changes (31 May).

7. The reasonable expectation of the mediator and parties will be that following the mediation the parties will identify whether particular topics are resolved between all, or some, parties. If some or all parties resolve a topic then they are likely to prepare agreed reports to the Court in which they describe the resolution reached and request the Court to confirm the consent on that possibly amended basis. If a party resolves an issue with Fulton Hogan (the consent holder) then that party will not be expected to lead evidence on that matter at the hearing unless the Court has queries about it.

Council assisting Templeton Residents Association with its appeal?

- 8. This is a resource consent application by Fulton Hogan for a quarry in the Selwyn District. The consent authorities are the SDC and ECan. The Council delegated authority to the Community Board to approve the Council's submission.
- 9. The Council lodged a submission. It engaged expert input to assess the effects of the application on the Christchurch District, including experts in groundwater quality, traffic and planning.
- 10. Experts giving evidence are professionally and ethically obliged to provide neutral independent opinions rather than to be advocates for the people paying for their services. The Council's evidence was consistent with that professional, ethical obligation.
- 11. The Council's evidence at the hearing from its experts sought changes to conditions that would address the concerns raised by the Council's experts.
- 12. Ecan and the SDC granted resource consent. Condition 40 of the land use consent issued by the SDC (RC185627) says:
 - 40. Heavy vehicle movements leaving or accessing the Roydon Quarry must use the direct route comprising Jones Road, Dawsons Road and State Highway 1 and must not travel on the following roads:
 - a) Jones Road west of the quarry access (between the access and Curraghs Road);
 - b) Dawsons Road north of Jones Road (between Jones Road and Maddisons Road); and
 - c) Jones Road east of Dawsons Road (between Dawsons Road and Railway Terrace).
- 13. Fulton Hogan has appealed against some of the conditions. It seeks that condition 40 be changed to:

The Consent Holder shall take all practicable steps to ensure heavy vehicles associated with the operations of the quarry shall not travel on those parts of any roads within the area identified on Figure RC185627B.





- 14. The Fulton Hogan appeal states that the reason that it seeks that change is that the effect of the condition 40 is that it allows only right-turn in and left-turn out. Fulton Hogan state that they can commit to that between the hours of 8pm and 6am because only Fulton Hogan vehicles can access the site between those hours (condition 39). During daytime hours they don't have control over the drivers employed by other companies accessing the site. They consider that the condition is unnecessary as the traffic network capacity and reasonably predictable driver pursuit of efficient routes does not require it.
- 15. The Council resolution in mid-2020 was to join as a party to the Fulton Hogan appeal in relation to that appeal point concerning condition 40.
- 16. The Council's Notice joining as a party to the appeal says that the sole part of the appeal in which the Council has an interest is condition 40, and that the Council opposes the change to that condition sought by Fulton Hogan.
- 17. The Templeton Residents Association (TRA) notice joining as a party to the Fulton Hogan appeal opposes all of the changes to conditions sought by Fulton Hogan, as they would have the effect of:
 - a. Extending the times during which cleanfill can be deposited at the quarry;
 - b. Relaxing quarry traffic routing restrictions;
 - c. Relaxing requirements to cover incoming and outgoing loads to/from the proposed quarry;
 - *d.* Limiting the scope of consent review;
 - e. Relaxing air quality monitoring requirements;
 - f. Enabling a range of activities to occur during particular wind conditions and when the ability to take water under the Appellant's water permit ceases; and
 - *g.* Avoiding the requirement to raise rehabilitated land in the event of an increase in groundwater levels.
- 18. The Council's involvement is limited in scope. The Council's role as a party is limited to just one of those matters. The scope of relief sought by the TRA is far wider.
- 19. As the extent of involvement and objective of involvement is so different, the Council and TRA should pursue their objectives separately.
- 20. With regard to the one matter on which the TRA and the Council both oppose the Fulton Hogan appeal condition 40 it is possible that the Council (by its delegated officers/attendees at mediation) and the TRA do not reach the same conclusion on appropriate resolution of that issue. That also makes any Council assistance to the TRA inappropriate.
- 21. As the Council is not here seeking the same result as the TRA there is no assistance that Council can or should provide to the TRA in these appeals.
