Long Term Plan 2021-2031

- Pre-consultation discussion
- Consultation Process early 2021
- Submissions received from Koukourārata and Ngāti Wheke
- Hearings held
- Long Term Plan adopted June 2021

- Didn't work well for Papatipu Rūnanga
- Unrealistic timeframes and not aligned with Te Hononga meetings
- Formal consultation process not appropriate
- Need to find a better way to reflect our evolving partnership





For Immediate discussion: Annual Plan 2022-2023

- Capital programme constraints Covid, supply chain
- In response to longstanding submissions, Koukourārata Drinking Water identified as a potential capital project – proposal to bring forward to 2022-23. Recommended by staff and endorsed by Councillors in draft.
- Formal consultation process to occur starting 11 March 2022

Initial thoughts for feedback

- In person meetings with each Rūnanga individually eg annual or six month
- One page summary of outcomes/long term goals
- Develop shared understanding of key priorities at early development phase of Long Term/Annual Plans.
- Facilitate discussion with relevant Council staff to scope/technical advice/co-design
- Report back process managed by Council (minimise burden on Rūnanga)
- Agree 1-2 joint projects eg climate resilience, social procurement **or** affordable housing
- Principal advisors to facilitate, and other Council staff to take responsibility for follow through
- Community advisor role
- Consider future and terms of reference for Te Hononga following 2022 Election and potential representation on Council decision making committees for LTP
