## 4. Updates on future budget and membership of the Committee and updated grant evaluation criteria

## 1. Purpose of Report Te Pūtake Pūrongo

1.1 The purpose of this report is to update the Committee on the process and criteria for applications for waste minimisation grants, and the invitation to Environment Canterbury (**ECan**) to consider membership of the Committee.

## 2. Officer Recommendations Ngā Tūtohu

That the Canterbury Waste Joint Committee:

- 1. Receive the information in the report and adopts the attached updated criteria for waste minimisation grants.
- 2. Consider whether unallocated budget for grants be retained by member Councils for spending on waste minimisation projects, or be carried forward for future allocation by the Canterbury Waste Joint Committee.

#### 3. Detail Te Whakamahuki

3.1 At the meeting of 2 August 2021 the Committee resolved as follows:

That the Canterbury Waste Joint Committee (CWJC):

- Recommends to member Councils that a new staff position be created to progress waste minimisation and management initiatives across the region and improve regional collaboration.
- 2. Recommends to member Councils that the budget for regional waste minimisation be increased from \$112,000 to \$192,000, to be adjusted annually for inflation.
- 3. Recommends to member Councils that Environment Canterbury be invited to become a member of the Committee on the same terms and conditions as its previous membership.

#### 3.2 Recommendations for a new position

As all member Councils have approved recommendations one and two above, the process of filling the proposed position can commence in the near future, to be funded from the increased \$192,000 budget.

### 3.3 Allocation of funds and funding criteria

At the meeting on 2 August the Committee did not allocate all of the available budget of \$112,000. That was because only applications that meet or exceeded the criteria are recommended for approval.

The Staff Group in October 2021 reviewed and updated the existing criteria, and are proposing updated criteria for consideration by the Committee – as set out in **Attachment A**. The main changes to the updated criteria are: clarifying that measurability of outcomes must be clearly



identified; adding circular economy principles to the criteria where relevant, e.g. the whole lifecycle of a product is accounted for; projects fostering innovation are preferred; and, providing for a funding limit of no more than \$50,000.

Only applications that meet or exceed the criteria are recommended by the Staff Group for consideration by the Committee, and some years all of the budget is allocated in terms of criteria eligibility, and some years not – as meeting the criteria is the key consideration.

Budget that is not allocated in a particular year currently falls back proportionally to the member councils to add to spending on separate waste minimisation projects in each district, as provided for in each Council's individual Waste Minimisation Plan, the Plan being a requirement of the Waste Minimisation Act 2008. An alternative option could however be for unallocated funds to be carried over to the following year.

#### 3.4 Membership

- 3.5 By end of February 2022 all member Councils had adopted the above recommendations of the Committee, and in March an invitation to join the Canterbury Waste Joint Committee was sent by the Chair of the Committee to the Chair of ECan. It is expected that a response to the invitation would be received ahead of the 2023 Financial Year, noting it is currently unclear if ECan will accept the invitation on the original terms (as a 25% funding partner).
- 3.6 With all members having agreed to the recommendations set out above, the budget will therefore increase from \$112,000 to \$192,000, adjusted for inflation, as from the 2023 Financial Year. Depending on ECan's potential membership and financial contribution, the provisional distribution of resourcing, based on current population spread, is set out in **Attachment B**.

### Grants for waste minimisation projects in Canterbury

The Waste Minimisation Act 2008 places responsibility on local government (territorial authorities) to promote effective and efficient waste management and minimisation within their districts.

The Canterbury Waste Joint Committee is responsible for advancing regional solid waste and hazardous waste minimisation in Canterbury. Regional waste minimisation initiatives actioned by the Committee are in addition to member Councils' responsibilities as required by the Waste Minimisation Act 2008, and as set out in each Councils' respective waste minimisation plan.

For projects that have a local application only, please see your council for funding available. The following Councils are represented on the Committee. For more information on this regional fund, please contact your council and ask to speak to a waste staff member

Environment Canterbury staff provide ongoing advice relating to minimising hazardous wastes and substances.

The Committee's Constituting Agreement [PDF, 23 KB] and Regional Waste Agreement [PDF, 7 KB] govern its operations. Decisions on grants are made by the elected members of the member Councils meeting as the Canterbury Waste Joint Committee, based on written Staff Group reports.

Projects supported by the Committee aim to link strategically with initiatives run by national organisations including WasteMINZ, Local Government NZ and the Ministry for the Environment. Government procurement can and should be used to support wider social, economic, cultural and environmental outcomes.

#### **Proposals invited**

The Committee annually invites proposals for suitable waste minimisation project proposals within the Canterbury region.

Proposals assessed to be of sufficient potential value and meeting the criteria set out below will be presented to the Committee. The annual budget is currently \$112,000.



## **Eligibility criteria**

- Only waste minimisation projects with broad regional application in Canterbury will be considered.
- Individual grants will be limited to no more than \$50,000 (excluding internal staff time).
- Co-funding from other sources of a minimum of 40% of total project costs will be preferred. Where possible projects should demonstrate cross-sector support/participation and/or ongoing viability
- The applicant must be a legal entity.

#### Assessment criteria

- Contribute towards one or more of: Waste avoidance; Reduction of waste to landfill; Recovery of
- Demonstrated ability by the applicant to deliver the project and relevant track record of applicant.
- Clearly identified measurability of outcomes.
- Circular economy principles should be considered, where relevant (e.g. the whole lifecycle of a product is accounted for).
- Projects fostering innovation are preferred.
- Details of self-funding and co-funding contributions for the proposed project must be provided

#### **Process timeline**

- Fully completed proposals in the format prescribed in the project grant application form ( Waste minimisation project grant application form [DOCX, 32 KB] must be emailed to cwjc@ccc.govt.nz and must be received by no later than 28 May.
- Evaluation: In June the Committee's Staff Group will assess applications (based only on submitted written material that complies with the requirements) to shortlist proposals. The Staff Group may request written additional information or clarification.
- The Staff Group will submit all applications received and evaluated to the Committee, plus a shortlist of proposed projects for consideration by the Committee.
- In August (subject to change) the Committee will consider and select successful projects. Successful an unsuccessful applicants will be notified by email of the outcome shortly thereafter.
