4.1 Cancer Society of New Zealand

Martin Witt, Manager Health Promotion - Cancer Society, updated the Committee on the Smokefree Aotearoa 2025 Action Plan. The Cancer Society are currently speaking with Youth Councils and organisations throughout the region to promote the Action Plan. Martin noted that the Action Plan is an opportunity for Aotearoa New Zealand to be the first country in the world to have a smokefree generation. It is expected that the Action Plan will go to a Parliamentary Select Committee in the coming months. Martin encouraged Te Pae Pīkari to make a submission when consultation opens.

7. Improving Diversity and Representation in our Research

Committee Comment

1. Officers from the Monitoring and Research team presented to the Committee on its Primary Research Programme. The Programme covers the Residents' Survey, the Life in Christchurch Survey and the Big Cities Quality of Life Survey. Officers noted that research participation from under 24 year olds is significantly low in comparison to other age groups.
2. Discussion was held following the presentation on how to increase youth participation. Suggestions included:
 - Less jargon and easy to read content.
 - Vouchers, discounts and other financial incentives.
 - Liaising with youth cultural groups and tertiary student clubs/organisations.
3. Following the discussion, the Committee resolved to include an additional resolution that requests the establishment of a group of young people who will be compensated to work with the Monitoring and Research team to strengthen the engagement of young people and assist with future survey development.
4. The Committee requested an update on resources available for civics education and work in that space.
