8. Overdale Drive - Proposed No Stopping Restrictions Community Board Comment

The Council Officer in attendance spoke to the accompanying report.

The Board also took into consideration the deputations from Mr Beasley, Mrs Killick and the correspondence from Mrs McLennan (Items 5.1, 5.5, and 7. of these minutes refers).

The Board considered that the recommended 12 metre length of no stopping restriction should be extended by six metres towards Dyers Pass Road. The Board also requested that the staff parking component of the Arvida on Cashmere Retirement Village (Rhodes) Resource Consent (RMA/2017/2543) be monitored, that monitoring of the safety improvements be undertaken for 12 months after the installation of the no stopping restrictions, and to investigate a right-turn lane on Dyers Pass Road into Overdale Drive.

9. 48 Battersea Street - Proposed Parking Time Restrictions Community Board Resolved SCBCC/2024/00006 (Original officer recommendations accepted without change)

Part C

That the Waihoro Spreydon-Cashmere-Heathcote Community Board:

- Approves, pursuant to clause 7 of the Christchurch City Council Traffic and Parking Bylaw 2017, and in accordance with section 12.4 of the Land Transport Rule: Traffic Control Devices 2004, that
 - a. the parking of vehicles be restricted to a maximum period of 30 minutes between the hours of 8.00am and 6.00pm Monday to Sunday, on the south side of Battersea Street, commencing at a point 91 metres west of its intersection with Colombo Street, and extending west for a distance of nine metres. These parking spaces are further restricted to 90 degree angle parking relative to the kerb line.
 - b. that the parking of vehicles be restricted to a maximum period of 120 minutes and be reserved for vehicles with an approved disabled person's parking permit, prominently displayed in the vehicle, on the south side of Battersea Street, commencing at a point 81 metres west of its intersection with Colombo Street and extending west for a distance of three metres. This restriction is to apply at any time. These parking spaces are further restricted to 90 degree angle parking relative to the kerb line.
- 2. Revokes, any previous resolutions pertaining to traffic controls made pursuant to any bylaw to the extent that they are in conflict with resolutions 1a and 1b above.
- 3. Approves that these resolutions take effect when parking signage and/or road marking that evidence the restrictions described in the report on the meeting agenda are in place (or removed in the case of revocations).

3.5 **Community Development**

3.5.1 The Waihoro Community Board Neighbourhood Building Project, Kia Ora Addington officially launched on Monday 19th February.

The neighbourhood building project is a collaboration between Neighbours Aotearoa and Waihoro Community Governance staff exploring a participatory cities model that creates a platform for citizens and community innovation, building social cohesion.



The launch of Kia Ora Addington saw a hive of activity at Manuka Cottage with approximately 60 local residents coming together to participate in a number of common denominator activities, as well as exploring the possibilities of what could be.

With nail painting, origami, outdoor games and a slip and slide there was something for all the whānau to enjoy.





4. Advice Provided to the Community Board

- 4.1 **Customer Service Request Report** A report on open and completed tickets (requests for service) in January 2024 is **attached**.
- 4.2 **Graffiti Snapshot Report** The 2023 yearly Graffiti snapshot **attached**.
- 4.3 Attached Memos include:
 - Community Parks Rangers Roles
 - Management of Elected Member Requests (Local Issues)
 - Wakefield Avenue Pedestrian Improvements
 - Rakaia Huts Selwyn chlorine exemption update
- 4.4 The Council Play Advocate, Manager of the Southern Centre Sensory Room, and Pioneer Stadium Project Manager advise that they are working together to meet the need for better waiting and play spaces for people with disabilities who visit Pioneer on a regular basis.

This project is being aligned with the planned refurbishment of the back entrance of Pioneer, next to the disability parking, to plan for a small sensory garden space, with some simple sensory play elements, interesting things to look at and touch and a mural.

This was after lots of feedback from families who attend the sensory room on a regular basis, that they often have to wait outside for their turn in an empty and underutilised area. Many residents who visit the Southern Centre from a residential programme wait in their van or wait for others in a van so this will provide a much more appropriate facility for them to enjoy instead.

There was input from a sensory design specialist who offered their advice to make this a space truly welcoming and accessible.



The ability to be creative with the way this refurbishment looks has meant that the hundreds of families who use the Southern Centre will have a fully accessible, fun and appropriate space to enjoy. It is an effective way of meeting the needs of this community and staff are sure it will be a very special place.

- 4.5 At the Community Board meeting on 10 August 2023 during Elected Member Information Exchange a member advised they had been asked by the Spreydon Neighbourhood Network to assess the need for a Community Centre for the people of Spreydon, the Board agreed to request staff investigate.
 - Staff responded: I have investigated this further. It is my professional opinion that the Spreydon Neighbourhood Network do not currently have the capacity to manage a Community Centre. Currently Spreydon Neighbourhood Network run regular meetings out of Whareora House, which encourages a connected, collaborative approach within neighbourhoods.
- 4.6 At the Community Board meeting on 10 August 2023 during Elected Member Information Exchange a member advised they had been in contact with Te Kura Whakapumau regarding its planned trip overseas to visit sites of importance to the 28th Maori Battalion. The Board requested staff contact Te Kura Whakapumau to offer support and guidance around sourcing funding for the trip.
 - Staff advised: Numerous attempts have been made to engage with Te Kura Whakapumau since September with no response. No further action or follow up.
- 4.7 At the Community Board briefing on 27 July 2023 during Elected Member Information Exchange a member advised that Mountfort Park requires watering. The Board agreed to advise staff that Mountfort Park requires watering.
 - Staff responded: We only water parks for establishment of new plantings and for sport turf to keep it alive. It is our aim to plant the right plants in the right place for survival. We will not be watering this park.
- 4.8 At the Community Board meeting on 15 June 2023, correspondence was received from the Sumner Community Orchard Hua Whenua regarding land use approval in the red zone. The Board requested staff progress a lease to this group.
 - Staff have advised that a lease has been approved by Head of Parks and paperwork for the lease is underway with the leasing team.
- 4.9 At the Community Board meeting on 15 December 2022 during Elected Member Information Exchange a Board member noted that a resident is concerned with the level of service at Cracroft Reserve and the surrounding area. The Board agreed to request staff advice on options to restrict access from Cracroft Reserve to a private driveway at 168 Hackthorne Road, which is used as a short cut to the reserve.
 - Staff advised: Access to the private driveway has been completed and the levels of service dictate what we do in the reserve, if there is something specific that a resident wants completed a snap send solve from the location with an image is the best way to relay this to staff.
- 4.10 At the Spreydon-Cashmere Community Board meeting on 31 May 2022 during Public Forum presentation from the Cashmere Technical Football Club, the Board agreed to request staff provide advice on the network plan for sports ground availability and to discuss with Cashmere Technical Football Club options for potential sites for sports ground with artificial turf and lights.
 - Staff responded: A briefing was given to the Waihoro Spreydon-Cashmere-Heathcote Community Board on the draft Sports Field Network Plan on 30 November 2023. The Plan articulates the strategy for the provision, development and performance of a network of well-



placed and appropriately developed sports fields across the city, including the provision of six artificial turf hubs., The Plan does not specifically cover allocation or availability of individual sports fields. Christchurch City Council allocates sports fields for seasonal sports use to the Regional Sports Organisations, on behalf of clubs, to enable the delivery of community sport. The allocations are made by the Council twice yearly prior to the commencement of the summer and winter sports seasons. However, the Plan does include a goal to quantify the type and location of the sports field network required to meet current and future community sporting needs., Once the Plan is adopted by Council and subject to receiving the funding requested in the LTP, there will be a robust engagement with clubs through their Regional Sports Organisations in order to work through the detailed actions contained in the Plan. This engagement will include investigating and determining the optimum placement of floodlit artificial turf surfaces in select locations in the city.

- 4.11 At the Spreydon-Cashmere Community Board meeting on 18 May 2022 during the Public Forum presentation from Spreydon Tennis Club the Board agreed to request that staff investigate and provide advice on the following: any past maintenance of the carpark and/or a schedule for any planned future maintenance; and options to upgrade the Spreydon Domain carpark.
 - Staff responded: 15/12/2023 This has been added to the list for line marking, pothole repair and sweeping for 2024. Not listed for renewal 2024. 28/8/2023 Waiting for Coronation Hall to be complete, road sweeping and new line marking can take place. Needs to be planned with contractors. 2/12/2022 Working on options need hard surface panel funding that is very limited. Will update if any progress.
- 4.12 At the Spreydon-Cashmere Community Board 16 February 2022 during the Public Forum presentation from local resident Mary O'Connor regarding her concerns about Somerfield Park; the Board agreed to request that staff: 3. Investigate improving pedestrian access through the fence around the perimeter of Somerfield Park. 4. Provide advice on whether future footpaths in parks can be built with some recycled material rather than asphalt.
 - Staff responded: We are using alternative materials for play spaces to provide safe fall options but I have not been able to find alternatives for paths.







2. Update Te take o tēnei Pānui

- 2.1 Council's Community Parks team comprises two distinct Ranger teams: Community Partnership Rangers and Field Rangers.
- 2.2 Field Rangers: This role primarily focuses on the physical upkeep and maintenance of the park. Duties may include landscaping, ensuring cleanliness, repairing amenities e.g., park benches, fences, and playground equipment.
- 2.3 Community Partnership Rangers: This role focuses on fostering relationships and collaborations within the community. They facilitate various park-related activities like volunteer planting, maintenance days, and coordinate initiatives aligned with community goals. Serving as a link between the Council and the community, they enhance community participation in park-related endeavours.

3. Conclusion Whakakapinga

3.1 While both roles attribute to the park's overall functionality and appearance, their focuses differ. Community Partnership Rangers prioritise community engagement and participation while Field Rangers concentrate on maintenance and upkeep.

Management of Elected Member Requests (Local Issues)

1. Purpose of this Memo Te take o tēnei Pānui

- 1.1 The purpose of this memo is to inform Community Board members of a change to the process of making localised issue information requests via the Community Governance teams.
- 1.2 The information in this memo is not confidential and can be made public.

2. Background

- 2.1 Customer Service Requests (CSRs), and requests for information relating to metropolitan issues, are managed by council staff within the Hybris software application. Presently, local issue requests raised by members are not managed in Hybris.
- 2.2 The Hybris application allows requests and issues to be tracked, managed, and reported in a consistent and standardised manner. Moving the handling of localised issue information requests into the Hybris application will extend the benefits of the system to these enquiries with all related requests being handled in the same way.
- 2.3 Hybris has now been updated to manage localised issue information requests and the Community Governance teams have been trained on using the system. The system will be used to manage requests received from **March 1, 2024**.

3. What is the Impact on Elected Members?

- 3.1 Elected Members do not need to do anything. From **March 1**:
 - Members can continue to raise requests for information via their Governance team in the same way they do now (by email, telephone, in person, etc.).
 - Governance teams will triage received requests as they do now, and where a request is lodged in Hybris, members will receive automatic emails confirming the ticket number of their request and the expected timeframe to respond to the request.
- 3.2 After a period of use, the staff will review the handling of requests via this process and look at reporting options for elected members.
- 3.3 As a reminder, all options for elected members making requests of staff are outlined in **Attachment A** including the localised issue information request option covered in this memo.

Wakefield Avenue Pedestrian Improvements

1. Purpose of this Memo Te take o tēnei Pānui

- 1.1 To provide information to the Waihoro Spreydon-Cashmere-Heathcote Community Board on proposed pedestrian improvements on Wakefield Avenue, Sumner.
- 1.2 The information in this memo is not confidential and can be made public.

2. Update Te take o tēnei Pānui

- 2.1 Improving safety on local roads in Christchurch is a priority for CCC with a Level of Service target of reducing the number of death and serious injury crashes on the local road network by 40% by 2030.
- 2.2 Wakefield Avenue forms part of the key link to Lyttelton via Evans Pass Road and Sumner Road, the main over-dimension and dangerous goods route between Christchurch and Lyttelton. Around 700 vehicles per day use this route, around 5% of which are heavy vehicles.
- 2.3 The site under consideration is at the southern end of Wakefield Avenue. The footpath on the southern side of the road terminates near the intersection with Sumnervale Drive requiring pedestrians to cross the road in order to continue on formed footpath.
- 2.4 There are no formal facilities to support pedestrians to cross Wakefield Avenue in this vicinity. Currently only cutdowns to the east of the intersection with Sumnervale Drive are provided to support pedestrians in negotiating a crossing of around 15m in length.
- 2.5 Requests for an improved pedestrian crossing facility in this location on Wakefield Avenue, Sumner have been received from members of the community for a number of years.
- 2.6 Improvements to pedestrian facilities would also benefit bus users in accessing bus services at the adjacent bus stop near Heberden Avenue.
- 2.7 The proposed scheme therefore incorporates:
 - A pedestrian refuge island and associated cutdowns (including tactile pavers)
 - A short section of new footpath to provide access to the crossing point
 - Flush median marking to delineate the pedestrian refuge island
 - Stop control on Sumnervale Drive (as the pedestrian crossing point is to the immediate left of the intersection)

- No stopping restrictions on the northern side of Wakefield Avenue to provide adequate visibility (crossing sight distance) at the pedestrian crossing point.
- 2.8 The Passenger Transport Engineer also has a proposal to provide bus layover facilities on Wakefield Avenue to the north of this site. Consultation on the two proposals would be undertaken simultaneously.

3. Conclusion Whakakapinga

- The next step for this project is to complete community engagement and report back to the Community Board. It is proposed to begin engagement in early March.
- 3.2 The delivery of this project will be through the Minor Safety Intervention programme. It is anticipated that construction on the project would be complete by the end of this financial

Rakaia Huts Selwyn chlorine exemption update

1. Purpose of this Memo Te take o tēnei Pānui

- 1.1 This memo provides an update on Selwyn District Council being granted a chlorine exemption for the Rakaia Huts water supply, and what this means for Christchurch City Council water supplies.
- 1.2 The information in this memo is not confidential and can be made public.

2. Update Te take o tēnei Pānui

- 2.1 Taumata Arowai has granted a chlorine exemption to Selwyn District Council for the Rakaia Huts supply. The supply serves a community of around 300 people.
- 2.2 Selwyn District Council has carried out substantial work to gain an exemption. This includes significantly upgrading components of their treatment plant, reducing water loss and investigating virus risks.
- 2.3 Before they remove chlorine from the supply, they also need to carry out additional work, including installing smart meters on all properties and increasing the intensity of their UV treatment.
- 2.4 While this decision does provide more clarity on what is required, the Rakaia Huts water supply is very different from the Christchurch water supplies. The size and complexity of a supply has a significant bearing on whether an exemption is achievable.
- 2.5 Given the requirements which must be met, smaller, less complex water supplies are more likely to be in a position to achieve an exemption, and it is unlikely that the Christchurch City supply as a whole will ever be in a position to be chlorine free.
- 2.6 Our focus is on ensuring all our supplies are compliant under the Drinking Water Quality
 Assurance Rules. Where we can, we will look to see what Christchurch supplies could achieve
 an exemption in future. It is most likely these will be for smaller less complex water supplies or
 zones such as Brooklands / Kainga and Birdlings Flat. Consultation would be required with
 those communities as there will be a cost if we are to be successful.
- 2.7 We've been working closely with Taumata Arowai over the last few months to better understand where exemption applications might be possible and what would be required to ensure we are in the strongest position to be successful if we were to make another application.
