In the two hour slot we opened for, we had over 30 groups of people through, and they all walked away with items successfully mended (including an elderly lady with a necklace she'd received at her high school graduation). There was a fantastic 'buzz' of people saying what a great idea it was, and asking if it would be on again in the future. 10 volunteers were there for 2-3 hours. With the community keen to have it happen again, and the volunteers going away feeling valued, we feel this would be a great event to happen in the community twice a year going forward. Items otherwise destined for landfill were getting a second life - that has to be good! As well as



people walking away with items mended, they had stayed a while and engaged with others, which was also part of the purpose of the event. A kind of 'community glue' you could say!

So all in all, the day was a great success, and we look forward to doing it all again.
